Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Shri Banavath Chinna Naik, R/o Bommarajupalli Village, Epuru Mandal, Guntur District, Andhra Pradesh regarding dispossession from land allotted to him under a patta after the construction of Nagarjuna Sagar Dam.

A representation dated 08.02.2022 from Shri Banavath Chinna Naik, R/o Bommarajupalli Village, Epuru Mandal, Guntur District, Andhra Pradesh, has been received by the Commission regarding dispossession from land allotted to him under a patta after the construction of Nagarjuna Sagar Dam. The petitioner states that their land was acquired for the Nagarjuna Sagar Project and they were subsequently allotted pattas under a rehabilitation scheme, and have been cultivating the said land for the past 23 years. However, revenue officials have now issued pattas to others in the same land without any enquiry or prior notice, leading to dispossession. The petitioner seeks the intervention of the Commission in the matter.

2. NCST vide notice dated 25.10.2024 sought facts and comments from the Collector and DM, Guntur within 15 days from receipt of the Notice.

3. The Collector & District Magistrate, Guntur, vide his letter dated 31.10.2022, has informed that the issue pertains to the jurisdiction of Palnadu District Accordingly, the matter has been forwarded to the District Collector, Palnadu, with a request to take necessary action and submit a report. There was no response received from District Collector, Palnadu. Hence, NCST decided to discuss the issue with the authority and the petitioner on 08.05.2025. Accordingly, a sitting notice was sent on 23.04.2025.

4. In the sitting, the District Collector, Palnadu was present. The District Collector has sought time for survey. The petitioner joined via phone. The petitioner reiterated his submission and requested for justice.

5. After discussion with the District Collector, Palnadu and petitioner, the following recommendations were made and action taken there on may be submit to NCST within 30 days from receipt of the minutes.

a. The District Collector, Palnadu, RDO and MRO, Epuru concerned may take immediate necessary action to survey the available vacant land and issue pattas for the dispossessed occupants.
