NATIONAL COMMISSION FOR SCHEDULED TRIBES

Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Shri Vankdavath Bilya S/o Venkatiah, V. Lalsingh S/o Bichya, and V. Surya S/o Dharma regarding names not being recorded in revenue records.

Shri Vankdavath Bilya S/o Venkatiah, V. Lalsingh S/o Bichya, and V. Surya S/o Dharma, have stated that they are legal heirs of late Lambadi Jethya and Lambadi Hamna, who along with Lambadi Lachma and China Rama were recognized as possessors and cultivators of 42 acres 34 guntas of land in Dasarlapally village, Kandukur Mandal, Rangareddy District, and were issued protective tenants certificates since 1950. Despite being declared legal heirs vide Letter No. B/660/99 dated 28.12.1999 and favorable orders from the Mandal Revenue Officer and the District Collector in Case No. F2/427/2000 dated 27.11.2005, their names were not recorded in the revenue records, and instead names of unrelated third parties were entered. These third parties—Jambula Raghunandan Reddy, Damodar Reddy and Ramnath Reddy—have allegedly encroached upon the land, threatened the petitioners and manipulated records with the support of revenue officials. Hence, do the justice.

- 2. The Commission issued notice to the District Collector & Magistrate, District-Rangareddy on 13.06.2025 for seeking facts and comments within 30 days from receipt of the Notice. The reply was not received, hence, The Commission decided to discuss the issue with the authority and the petitioner on 25.07.2025. Accordingly, a Sitting Notice was sent on 18.07.2025. The Collector & District Magistrate, Rangareddy vide letter no. C1/NCST/2024/2025 dated July, 2025 has sought exemption and deputed RDO, Kandukar Division to attend the sitting.
- 3. In the sitting, RDO, Kandukur Mandal, Rangareddy District and petitioner were present. The petitioners have reiterated stated that they are legal heirs of late Lambadi Jethya and Lambadi Hamna, who along with Lambadi Lachma and China Rama were recognized as possessors and cultivators of 42 acres 34 guntas of land in Dasarlapally village, Kandukur Mandal, Rangareddy District, and were issued protective tenants certificates since 1950 their names were not recorded in the revenue records, and instead names of unrelated third parties were entered. All the documents were also produced by the petitioners. The Revenue Divisional Officer present has acknowledged the facts and has assured that he being the competent authority will take immediate necessary action. The RDO, Kandukur Mandal, Rangareddy District provided the letter no. C1/NCST/2024/2025 dated July, 2025 of the District Collector and Magistrate of Rangareddy. In this letter, the facts and comments has been mentioned and informed that a notice will be issued to the petitioner for conducting the hearing to resolve the issue.
- 5. After hearing the petitioner and authority, the following recommendations are made and the ATR may be submitted in 60 days.
- a. As RDO is the competent authority, Notice may be given to the concerned and 38(E) Protective tenants certificate may be issued after necessary procedure.

b. If required necessary legal assistance may be provided to the petitioners as per their request.
