## **National Commission for Scheduled Tribes**

Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Dr. Ram Lakhan Meena, Distt- Karauli (Rajasthan) regarding Non Selection to the post of Administrative Officer (Doctor) in United India Insurance Company Ltd.

Dr. Ram Lakhan Meena, V&P-Kariri, Tehsil Todabhim, District Karauli, Rajasthan has submitted a representation regarding non-consideration for selection to the post of Administrative Officer (Doctor) under ST category in United India Insurance Company Ltd. for the recruitment year 2023. He stated that although three vacancies were advertised for ST candidates, only two candidates were given joining, leaving one ST seat vacant. Despite fulfilling all eligibility criteria and seeking clarification through RTI, he has not received any response and requested for justice.

- 2. The Commission issued notice to Chairman-Cum-Managing Director, United India Insurance Company Ltd, Chennai on 16.05.2025 for facts and comments within 10 days from receipt of the Notice. The reply was not received, hence, NCST has decided to discuss the issue with the authority and the petitioner on 11.07.2025. Accordingly, a Sitting Notice was sent on 25.06.2025.
- 3. The CMD, UIICL, Chennai vide letter no. Ho:HRM:Res.Cell:2025 dated 4.7.2025 has furnished the facts and stated that the UIICL has followed the due procedure in the recruitment such as notification of vacancies for the post and vacancies reserved for ST category having been duly filled. Hence, the matter may be closed. Further, he sought exemption and deputed DGM, HRM to attend the sitting.
- 4. In the sitting, DGM, HRM alongwith other officers of UIICL and petitioner were present. The petitioner has reiterated his earlier submission and requested for justice. The officers of UIICL reiterated the facts submitted by CMD, UIICL vide letter dated 4.7.2025 (as mentioned in Para 3) and informed that vacancies reserved for ST category having been duly filled. Hence, the matter may be closed.
- 5. After discussion with the officers of UIICL and petitioner, it was observed that the vacancies reserved for ST has already been filled by UIICL. Hence, the case may be closed.
