Subject: Rejoinder to NIOS Written Statement dated 25.06.2025 in connection with Applicant's Representation for removal of anomalies in implementation of the Provisions for RESERVATION as enshrined in Constitution of India for ensuring due promotion of the Applicant to the post of Section Officer retrospectively w.e.f. either 1.8.2010 or 01.01.2011 or even 27.05.2011 with consequential promotion to the post of Assistant Director in National Institute of Open Schooling (Formerly National Open School) w.e.f. 2019 against reserved quota for Scheduled Tribe.

### Respectfully submitted:

The humble applicant submits that the purported factual position narrated in NIOS WS dated 25.06.2025 is only partially correct and hence the same are denied at the outset and the contents of applicant's application are reiterated.

#### Para-wise Rejoinder to WS

1 to 4. That it has rightly been admitted by NIOS that two members committee consisting of Joint Commissioner, KVS and Deputy Director, IGNOU had graciously recommended granting the promotion to post of Superintendent with retrospective effect from 01.08.2005 with all consequential benefits respectively as per point 4 and 6 of said recommendations dated 12.08,2013.

The committee had thereby recommended granting all consequential benefits including SENIORITY w.e.f. 01.08.2005.

Committee had thereon further recommended to place the case of applicant in next DPC for his promotion as Section Officer (against post earmarked as ST).

As per applicable Recruitment Rules for the post of Section Officer, the candidate requires FIVE years qualifying service in Feeder post of Superintendent.

For his promotion to the post of Section Officer, the humble applicant had therefore fulfilled the necessary criteria of FIVE years qualifying service in the Feeder post of Superintendent on 02.08.2010 on account of his retrospective promotion to the post of Superintendent w.e.f. 01.08.2005 as per recommendations of the said two members committee.

Therefore, for implementing the above cited recommendations of the said two members committee, the NIOS Personnel Branch vide their Note Sheets dated 13.08.2013, 20.08.2013 Ind 30.08.2013 examined the matter thread bare and duly recorded therein as follows:

"AS PER THE RECOMMENDATION NO.6 OF THE COMMITTEE, SH. MUKESH KUMAR SHALL ALSO BE ELIGIBLE FOR ALL THE CONSEQUENTIAL BENEFITS. ACCORDINGLY HE WAS ALSO ELIGIBLE FOR PROMOTION TO THE POST OF SECTION OFFICER ON COMPLETING 5 YEARS OF REQUIRED SERVICE AS SUPERINTENDENT IN THE VACANCY YEAR 2011-12. THE DPC FOR PROMOTION FOR THE POST OF S.O. WAS HELD IN THE MONTH OF MAY, 2011 AND SUPERINTENDENTS WERE PROMOTED AS SECTION OFFICER W.E.F. 27.5.2011. AS SH. MUKESH KUMAR WOULD HAVE ASLO BEEN ELIGIBLE FOR PROMOTION TO THE POST OF SECTION OFFICER AGAINST ONE VACANT POST EARMARKED FOR ST, SH. MUKESH KUMAR MAY ALSO BE CONSIDERED FOR PROMOTION TO THE POST OF SECTION OFFICER W.E.F. 27.5.2011."

It is thus a proven fact that there was clear vacant post of Section Officer earmarked for ST and even NIOS had truly understood purport of said recommendations of 2 members committee and had thus initiated due process on 13.82013 for promoting applicant to the post of Section Officer retrospectively from 27.5.2011.

Hence it is highly unjustified/unethical to make any effort to deny said promotion of applicant to the post of Section Officer retrospectively from 27.5.2011.

However, due to some behind the curtain unlawful manipulations by vested interests, the crooked officials of NIOS had surreptitiously buried the said previously initiated process of promoting the applicant to the post of Section

Officer retrospectively w.e.f. 27.5.2011 in gross violation of the recommendations of the said two members committee.

It is further evident from NIOS Personnel Branch File No.41-10/2013/NIOS/Pers. note sheet dated 11.12.2013 that consequent upon sanction of additional posts at various levels vide MHRD (Department of School Education & Literacy, GOI) letter dated 04.02.2013, there was alleged dearth of Superintendents having required qualifying service for promotion to the available posts of Section Officer. In subsequent note sheet dated 18.12.2013, it has categorically been recorded that there are 19 vacant posts of Section Officer and out of which 2 posts are earmarked for ST Category and no Superintendent is eligible for the post of Section Officer except Shri Mukesh Kumar (ST) category as on that said date.

Consequently, NIOS Secretary had on 27.12.2013 recommended approving and granting the promotions to vacant posts thereof upon holding of DPC and in culmination of this delayed manipulated process, the applicant had been denied of his due promotion to the post of Section Officer till 2016 due to no fault on his part though there was clear vacant post of Section Officer earmarked for ST and the applicant had completed required qualifying five year service in the feeder post w.c.f. 02.08.2010 as explained above.

5 to 9. That NIOS has rightly admitted that on being aggrieved by the above stated unlawful denial of his right of RESERVATION in gross violation of the provisions enshrined in the Constitution of India, the humble applicant had requested the parent governing Ministry of Human Resources Development to implement the Reservation Policy as mandated by Department of Personnel & Training.

This Hon'ble National Commission for Scheduled Tribes had also been very kind to request the Secretary, Department of School Education and Literacy vide Letter No. NCST-16012(MHRD)/6/2020-RU-III dated 03.12.2020 to take appropriate action and send a report to the Commission.

The facts and records in the matter were manipulated by vested interests in NIOS and ultimately the due rights of reservation were sought to be denied.

10 to 13. The vested interests in NIOS placed manipulated and abridged records before the members of newly appointed committee for obtaining a finding devoid of just and fair appraisal of the true facts. On being denied of his due rights of reservation despite repeated efforts, the humble applicant has therefore approached this Hon'ble Commission for justice.

Had NIOS authorities promoted the applicant to the post of Section Officer retrospectively w.e.f. 27.5.2011 as had been proposed by themselves in their Note-Sheets dated 13.08.2013, 20.08.2013 1nd 30.08.2013, the humble applicant would have by now been rightly promoted to the post of Assistant Director w.e.f. 2019 on completing qualifying eight years' service in feeder post of Section Officer.

However, only due to unlawful machinations of the vested officials of NIOS, the applicant has been deprived of his promotion to the post of Assistant Director since 2019.

Hence the applicant has been forced to seek shelter under this Hon'ble Commission for justice.

### PRAYER

In view of the above, the applicant humbly prays for as follows: -

- Urgent sorting out of the anomalies committed by NIOS in implementation of the PROVISIONS OF RESERVATION AS ENSHRINED IN THE CONSTITION OF INDIA:
- II Granting of all due benefits of RESERVATION to the applicant by revising all relevant Orders of NIOS;
- III Holding in abeyance all ongoing process in NIOS towards granting any promotion to the post of Assistant Director to any candidate on regular/ad-hoc basis till sorting out of the long pending representations under reference in order to prevent prejudice to legitimate rights of the applicant.
