Minutes of the sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Shri B.Ramesh, Superintendent, Board of Intermediate Education (BIE), Tadepalli (Andhra Pradesh) regarding revision of seniority list by protecting his seniority.

Shri B. Ramesh, Superintendent, Board of Intermediate Education, Tadepalli (Andhra Pradesh) vide his petition dated 28.05.2025 has stated he was promoted as Superintendent in 2019 at Roster Point No. 83 (ST). However, during 2023 his candidature for promotion to Deputy Secretary was denied on the ground that adequacy was achieved. He represented to the Secretary, BIE, contending that adequacy should be calculated on the total cadre strength, especially since the bifurcation of TS and AP was finalized only on 16.10.2023. Despite this, his promotion was denied. Hence, do the justice.

- 2. The Commission issued notice to the Secretary, Government of Andhra Pradesh, Board of Intermediate Education, Tadepalli, Guntur on 21.07.2025 for seeking facts and comments. The Reply was not received, hence, the Commission decided to discuss the issue with the authority and the petitioner on 09.09.2025. Accordingly, a Sitting Notice was sent on 29.08.2025. The Secretary, BIE, Govt. of Andhra Pradesh vide letter dated 8.9.2025 has sought exemption and deputed Joint Secretary (Admin) to attend the sitting.
- 3. In the sitting, the Joint Secretary, BIE along with other Sr. officers of BIE and petitioner were present. The petitioner reiterated his earlier submission and requested to audit RoR implementation for the second cycle in the Superintendent Cadre of BIE. The officers of BIE provided the various documents in respect of the case and stated that the Seniority of the petitioner at SI No. 5 in the cadre is correct and in accordance with the rule. The Department has also provided the proceeding dated 30.12.2023 of the Secretary, BIE regarding speaking order on final seniority list of Superintendents. In the Speaking Order, it has been mentioned that this order subject to the condition of pending finalization of bifurcation process, outcome of the modalities of bifurcation, final allocation of employees, cadre strength, vacancies from APBIE/TSBIE review of seniority consequent on allocation of the employees to both States and subject to the various writ petitions/writ appeals pending in the Hon'ble High court & other courts.
- 4. After discussion the above officers of BIE and petitioner, the following recommendations were made and action taken thereon may be submitted to NCST within 30 days from receipt of the minutes:-
 - The Department may ensure for the strict implementation of the Rule of Reservation in its true spirit .It appears that only 4 out of the 6 posts are shown in the Roster points.
 - · The Roster points and rule of reservation implemented from 2014-15 may be submitted to NCST.
 - It may be explained as to why it is reverted when no one has objected. If there are objections made by anyone the same may be produced to the petitioner and to NCST.
 - The department may explore the possibility of creating the supernumerary post as only one ST person is being affected.
 - The Department may further explain as to why new rosters are not being implemented and continuing with the same rosters in AP when Telangana is implementing the fresh new rosters.
 - The Travel Allowance and Special Leave may be reimbursed/ granted in favor of the petitioner, as per rules.
