Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Shri Major Kodigala Chandraiah(Retd), Madhusudan Nagar, Jatni, Khurda (Odisha) regarding immediate assistance for eviction from alleged encroachment on his land.

Major Kodigala Chandraiah (Retd) vide his representation dated 02.12.2024 has stated that his neighbor (Illayat Ali Khan, a railway employee) has encroached upon 3 decimals of his legally purchased 10-decimal land in Madhusudan Nagar, Jatni, Khurda, Odisha. Despite multiple representations to the Jatni Tahsildar, civil court and local authorities, he alleges that no action has been taken due to his lower community status. He further alleges that the opponent with the help of local goons, constructed a wall on the encroached land while intoxicated, creating a threatening and unsafe environment. He has requested for justice.

- 2. NCST vide notice dated 03.01.2025 has sought facts and comments from the Collector and DM, Khordha within 30 days for receipt of the Notice. There was no response from authority, hence, NCST has decided to discuss the issue with the concerned authority on 6.6.2025. Accordingly, a sitting notice was sent to all concerned on 28.5.2025.
- 3. The Collector & District Magistrate, Khordha vide letter no. 1547 dated 30.05.2025 has informed that although the petitioner purchased land in 2004 through a registered sale deed, the said Khata and Plot number do not exist in the Hal Settlement RoR published on 31.10.2013. On verification, it was found that the corresponding original Sabik Khata No. 1104 and Plot No. 2931 are recorded in Anabadi Khata with Shree Jagannatha Mahaprabhu Bije Puri Taraf, Jagannath Mandir Parichalana Committee, Puri as Khewatdar. Therefore, the Tahasildar has no jurisdiction to demarcate or interfere with temple land, and hence encroachment on the petitioner's land could not be established. It was also confirmed by the Sub-Registrar, Jatni, vide letter dated 25.02.2025 that the sale deed is genuine, but as the land stands in the name of Lord Jagannath in the Sabik records, the issue has been referred to the Temple Administration, Jagannath Mandir, Puri, for necessary action.
- 4. In the sitting fixed for 6.6.2025 the Collector & District Magistrate, Khurda and petitioner were not present. Hence, the sitting was postponed and rescheduled for 9.9.2025. Accordingly, a Sitting Notice was sent on 28.08.2025.
- 5. In the sitting, the Collector & District Magistrate, Khurda and petitioner were present through Video Conference. The petitioner reiterated his earlier submissions and requested to protect him from the opponent and also get his land free from the encroachment. the Collector & District Magistrate, Khurda reiterated their dated 30.5.2025. Further, it is also stated that the petitioner has not submitted any application regarding protection from the opponent. It was assured that the matter will be enquired fairly for justice with the petitioner.
- 6. After discussion with the Collector & District Magistrate, Khurda and petitioner, the following recommendations were made and action taken there on may be submitted to NCST within 30 days from receipt of the Minutes.
 - The petitioner is advised to meet the District Collector & Magistrate, Khurda for guidance and further course of action in the matter
 - The Superintendent of Police, District- Khurda is advised to conduct an enquiry on the said plot and provide the protection to petitioner.
