Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Shri K. Srikanth, S/o K. Srinivas, Director, S3 Medical Solutions, Hyderabadregardingcheating and refusal of police to take necessary action.

Shri K. Srikanth, S/o K. Srinivas, Director, S3 Medical Solutions, Hyderabad, vide his petition dated 16.01.2025, has alleged that he was induced by Krishna Rao Muttamsetty and others to supply medical equipment worth ₹85,34,000/- for a proposed Nova Medical College at Jafferguda, out of which only ₹34,10,000/- has been paid, leaving a balance of ₹51,24,000/-. Despite multiple follow-ups, the accused have allegedly evaded repayment and issued life threats, including caste-based abuses and threats of false implication by women associates. He reported the incident to SHO Abdullapurmet PS and ACP Vanasthalipuram, leading to FIR No. 14/2025 dated 06-01-2025 under relevant sections of BNS and SC/ST PoA Act. However, he contends that key sections relating to cheating and criminal breach of trust were omitted and that the investigation is being conducted in a biased and lackadaisical manner. He seeks the Commission's intervention to ensure a fair investigation and inclusion of all relevant sections in the FIR.

- 2. NCST vide notice dated 28.01.2025 sought facts and comments from the Commissioner of Police, Rachakonda, Hyderabad within 30 days. The reply was not received; hence, NCST has decided to discuss the issue with the authority and the petitioner on 05.05.2025. Hence a sitting notice was sent on 21.04.2025.
- 3. The Commissioner of Police, Rachakonda vide letter dated 3.5.2025 has furnished the facts and status of action taken by the Police Department in the matter. The Commissioner of Police vide communication dated 4.5.2025 has sought exemption and deputed ACP, Ibrahimpatnam Division of Rachakonda to attend the sitting.
- 4. In the sitting, ACP, Rachakonda and petitioner were present. The petitioner has reiterated his earlier submission and has also informed that cheque issued by Nova Medical Colleg management is not honored due to insufficient balance and though a complaint is filed on this issue no action is taken by police till now. He further requested for fair investigation in the matter. The ACP, Rachakonda has reiterated the facts submitted by Commissioner of Police, Rachakonda dated 3.5.2025 and informed that the legal opinion is to be obtained from Add. Public Prosecutor of Hon'ble Trial Court (Hon'ble Metropolitan Session Court, for trial of SC/ST (PoA) Act, cases) at LB Nagar, RR District.
- After discussion with the ACP, Rachakonda and petitioner, the following recommendations were made and action taken thereon may be submitted within 30 days from receipt of the Minutes.
 - a. The police may file a cheating case against the Nova medical college under Section 420.
 - b. The Medical Board may take action against the said Medical College by blacklisting it.
 - c. The medical college may be ordered to pay the pending balance immediately with interest for the delay and penalty for the inconvenience and humiliation meted by the petitioner.
