Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Dilkusha Guest House, Hyderabad in the case of Shri Tejavath Chandru,, Mahabubabad District regarding Non issuance of ROFR Pass Book.

Date of the Sitting: 24.06.2025 at 01:00 PM Participants in the Sitting: As per Annexure NCST/DEV-4437/AP/9/2025-RU-III

The petitioner, Shri Tejavat Chandru, S/o Lalu, resident of Thotada Tanda, Marrimitta village, Gudur Mandal, Mahabubabad District, vide his petition dated 20-06-2024 has requested the Commission to facilitate issuance of Pattadar Passbook in his name for land measuring 4 acres and 30 guntas situated in Survey No. 1038 of Rallavagu, under Marrimitta limits. He states that he is already receiving Rythu Bandhu financial assistance for this land and seeks intervention to obtain the New Podu Pattadar Passbook for the said land.

- 2. The Commission issued notice to District Collector & Magistrate, Mahabubabad and District Forest Officer, Mahabubabad vide NCST letter dated 27.02.2025 seeking facts and comments within 30 days. No reply was received from the authority. Hence, the Commission has decided to discuss the issue with the authority and the petitioner on 24.06.2025. Accordingly, a Sitting Notice was sent on 20.06.2025.
- 3. The petitioner has attended the hearing on phone. The DTDO, Mahabuababd and RDO, Mahabubabad have attended the hearing.
- 4. The petitioner reiterated that he is already receiving Rythu Bandhu financial assistance for this land and seeks intervention to obtain the New Podu Pattadar Passbook for the said land.
- 5. The authority has informed that the online portal is now closed and there is no option to generate the passbook.
- 6. After hearing to both the petitioner and the authorities the following recommendations are made and the ATR may be submitted in 30 days time.
- a. The DLC may examine the case if it is the old ROFR title deed given during 2008-2010 or the new pass book issued during the podu drive in 2022-23.
- b. The Government may be addressed to resolve the issue of providing the duplicate copies of the passbooks if they are lost or in the cases where they are made online but the physical passbooks are not yet issued.
- c. The bogus passbooks/title deeds may be weeded out by a coordinated exercise of Revenue, Forests and Agriculture Departments so as to save the Government exchequer where the rythu barosa assistance is disbursed without the actual physical existence of the said land.
