## NATIONAL COMMISSION FOR SCHEDULED TRIBES

Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Dilkusha Guest House, Hyderabad in the case of Shri Kethavath Babu Ram Naik, State President of Telangana Girijana Samskruti Parirakshana Samithi Mobile No. 09959054491 regarding abuse and assault of the Sub Inspector of Police, Neradugommu Police Station.

Shri Kethavath Babu Ram Naik, State President of Telangana Girijana Samskruti Parirakshana Samithi, vide his representation dated 04/06/2025 has alleged that SI Satish of Neradugommu police station abused and assaulted ST individuals, namely Mudavath Babu and his father, when they approached him to lodge a police complaint. He allegedly abused by community name and took a bribe. On 24/05/2025, he reportedly assaulted them again at their residence, and later on 26/05/2025, while the victim was undergoing treatment at a government hospital, the SI allegedly abused and threatened him in front of others, including tribal women. Despite complaints to higher police authorities, no action has been taken. The petitioner has therefore requested the Commission to register a case under the SC/ST (PoA) Act against SI Satish citing continued misuse of power, verbal and physical abuse, and derogatory behavior towards ST individuals.

- 2. The Commission issued notice to the Superintendent Of Police, District-Nalgonda vide NCST letter dated 16.06.2025 seeking facts and comments within 05 days. However when the reply was not received a sitting notice was issued on 25.6.25 for hearing on 11.7.25 for which the authorities were absent. Hence, the Commission has decided to discuss the issue with the authority and the petitioner on 28.08.2025. Accordingly, a Sitting Notice was sent on 13.08.2025.
- 3. The Petitioner Kethavath Babu Ram Naik has attended the hearing. The authority District Superintendent of Police has also attended the hearing.
- 4. The petitioner reiterated his plea. The authority has informed that as per the enquiry it is revealed that the issue started with the petitioner Mudavath Babu S/o Redya has harassed Smt Mudavath Lali W/o Mudavath Secva which led to the frequent quarrels between the two families. This incident formed the subject matter of Cr.No.59/2024 U/s 78, 351(2) BNS of PS Neredugommu and subsequently the fresh quarrels again took place between the same families which became the subject matter of Cr.No.39/2025 ND Cr.No,40/2025 of PS Neredugommu. It is informed that the ASP Devarakonda enquiry further revealed that the witnesses ie, Driver of police vehicle affirmed that the SI did not abuse the petitioner and on the contrary the petitioner and henchmen themselves have picked up the quarrel with SI and pressurized him to register an attempt to murder case against their rivals. Further Cr.No.39/2025 was registered on the same day at 16.00 Hrs on the complaint of Sri Mudavath Redya, father of the petitioner which categorically disproves the allegation of non receipt of the petition.
- 5. After hearing to the petitioner and authority the following recommendations are made and ATR may be submitted in 15 days from the receipt of the Minutes.
- a. The videos and pictures produced by the petitioner may be examined and the available CC Camera footage may be examined to ascertain the facts.

b. A detailed enquiry may be made on the allegations of bribe, threatening of the tribal women and famly members and necessary action may be taken if the allegation is proved.
