## National Commission for Scheduled Tribes

Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Dilkusha Guest House, Hyderabad in the case of Shri Ajmeera Ramdass, former Executive Engineer and Founder-President of SC/ST Employees Association in Telangana Police Housing Corporation regarding various injustices being faced by STs in TSPHCL.

Shri Ajmeera Ramdass, former Executive Engineer and Founder-President of SC/ST Employees Association in Telangana Police Housing Corporation, vide his representation dated 16.05.2025, stated that after serving 30 years and retiring in 2024, he raised issues regarding denial of promotions to ST employees, non-payment of DA and IR, and irregularities in transfers and promotions. He alleged that despite government orders, retired persons like R.C. Kumar and Shailaja, aged about 70 years, were retained on outsourcing with high salaries while ST employees were denied promotions. On objecting to these irregularities, the petitioner claims that MD Ramesh Reddy, in meetings held on 07.11.2024 and 03.02.2025, made casteist remarks against ST employees and humiliated them in the presence of others. He further alleged that when he requested clearance of pending DA and IR dues, MD Ramesh Reddy, along with R.C. Kumar and others, conspired to falsely implicate him in a police case, resulting in an FIR at Saifabad Police Station on 09.05.2025. The petitioner has sought protection, registration of atrocity and criminal cases against Ramesh Reddy (MD), R.C. Kumar, Suprasanna, Tulasi Dhar Reddy, and Dinakar, and legal action for the caste abuse and harassment faced by him and other ST employees. Copies of complaints filed with Saifabad Police Station and National Commission for Scheduled Tribes, New Delhi, are enclosed.

2. NCST vide notice dated 19.06.2025 sought facts and comments from the Principal Secretary, Home Department, Government of Telangana within 30 days.

3. No reply was received by the Commission. The Commission decided to discuss the issue with the authority and the petitioner on 28.08.2025. Hence a sitting notice was sent on 13.08.2025.

4. The petitioner has attended the hearing. The authority ie, MD, Telangana Police Housing Corporation has attended the hearing.

5. The petitioner has informed that Shri RC. Kumar, aged 66, belonging to Andhra region working on out sourcing basis & is drawing an unjust salary of Rs. 2.5 lakhs in violation of government order. Till date his outsourcing order is not approved in the Government. He has also indulged in caste - based abuse.

6. Further it is informed by the petitioner that Shri. Tejawath Eshwar, ST executive engineer, with roster cum seniority no.8 is due for promotion as Superintendent Engineer. However, the post has been wrongly occupied by Mr.Tulasidhar Reddy with roster cum seniority no: 11, who was promoted irregularly, allegedly using his influence with the Managing Director Police Housing Corporation.

7. The authority, M.D., TGPHCL has informed that based on the Government directions and Board Resolutions, no retired person of the Corporation is being re-employed. With regard to engaging the services of Sri R.C. Kumar, a professional Chartered Accountant and Smt. K. Sailaja, Retired Principal and District Judge services, it was clarified by the M.D. that they are not retired employees of the Corporation. Their services are being utilized as Consultants in view of their vast experience and dire need of the Corporation due to non-availability of qualified, eligible and experienced candidates and that they were hired based on the Board of Directors approval dated 04.04.2025. Their services are required to be continued due to administrative necessity of the Corporation.

8. The authority further informed that he has no role with regard to the registration of a case against Sri A. Ramdas, DEE (Retd.) in Saifabad Police Station and he has no objection if complainant withdraws case against him and Sri A. Ramdas is at liberty to discuss the issue with the complainant in a conducive manner and settle it amicably.

9. Further in respect of In respect of applicability of Roster Point No. 8, claimed by Sri T. Eswar against promotion to the post of Executive Engineer will be examined by APSPHCL, Mangalagiri, Guntur District only after finalizing the combined Seniority List of EEs in accordance with common judgment dated 28.11.2024 passed in WA Nos. 267/2017 and 268/2017 passed by the Hon'ble Telangana State High Court and communicate the same to TGPCHL for taking further action.

10. After hearing to the petitioner and authority the following recommendations are made and ATR may be submitted in 30 days time.

i. The Managing Director, Andhra Pradesh State Police Housing Corporation Ltd., Mangalagiri, Guntur may take necessary action on the Corporation Lr.No. HR/F.No.21224/2025-26/1068, dt: 16.07.2025 regarding revision of combined Seniority List of EEs in view of common judgment dated 28.11.2024 passed in WA Nos. 267/2017 and 268/2017 by the Hon'ble Division Bench of Telangana High Court and communicate the same to TGPCHL for taking further action and MD, TGPCHL may actively pursue the matter.

ii. The MD, TGPCHL may take necessary action and ensure that Shri RC Kumar and Shri Dinakar withdraw the case registered against Shri. A. Ramdass in Saifabad Police Station.

iii. The MD, TGPCHL may ensure that ST regular employee may be included as Member in the Internal Grievance Redressal System and friendly relations may be fostered among the Management and Employees.

iv. The petitioner is advised to register separate petitions on specific cases of grievances to avoid ambiguity.
