NATIONAL COMMISSION FOR SCHEDULED TRIBES

Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Dilkusha Guest House, Hyderabad in the case of Shri B. Srinivas, ATM (Logistics), NZB regarding alleged humiliation and caste discrimination.

Date of the Sitting: 29/08/2025, 03:20 PM Participants in the Sitting: As per Annexure NCST/SER-2384/TS/534/2025-RO-BHUV/RU-III

Shri B. Srinivas, ATM (Logistics), NZB, vide his representation dated 26.05.2025, has stated that he belongs to the Lambada ST community and joined RTC as Mechanical Supervisor in 1999, later promoted as Depot Manager in 2019. He alleges that in June 2022, while serving as Depot Manager at Mahabubabad Depot, he was suddenly reverted without any prior memo, charge sheet, or punishment and replaced with a junior. He claims that MD TGRTC acted with personal vengeance due to his caste, harassed him by creating a new post in a distant location (Adilabad/Nizamabad) and posted him there deliberately. He was allegedly denied leave, humiliated in meetings, and threatened with removal. He further states that despite repeated appeals and visits, he was subjected to fabricated inquiries in April—May 2023 without issuing a proper charge sheet, followed by a charge sheet and show-cause notice in April 2024, and subsequently removed from service through illegal procedures. His appeals to MD and Chairman were allegedly ignored or delayed for over a year, leading to 13 months of unemployment, severe financial crisis, his mother's death, father's ill health, and disruption of his children's education. He requests reinstatement as Depot Manager near his wife's workplace, payment of salary and benefits for the loss period.

- 2. The Commission issued notice to the Special Chief Secretary, Transport Department Govt. of Telangana vide NCST letter dated 08.07.2025 seeking facts and comments within 15 days.
- 3. Reply was not received hence the Commission has decided to discuss the issue with the authority and the petitioner on 29.08.2025. Accordingly, a Sitting Notice was sent on 20.08.2025.
- 4. The petitioner has attended for the hearing. The authority ie, Spl. Chief Secretary, Transport, Roads and Buildings Department has attended the hearing.
- 5. The petitioner reiterated his plea. The authority has informed that he was involved in several managerial lapses leading to the loss to the coroporation and misappropriations and the chargesheet is also sent as per the procedure but the change of address is not informed to the office, hence it did not reach the petitioner.
- 6. After hearing to both the petitioner and authority the following recomendations are made. The ATR may be submitted in 45 days time.
 - a. The details of the enquiry and chargesheet may be submitted to NCST. The videorecords of the enquiry process if any may be submitted.
 - b. It may be esnured that an SC/ST officer may be included in the enquiry team always. Further the internal grievances committee may be setup and may periodically meet to acknowledge and hear to the grievances of the employees if any in TGRTC with regard to service matters and other issues.
 - c. Considering the vulnerability of the petitioner, case may be laid before the upcoming Board meeting and the plea of the petitioner may be considered.
