NATIONAL COMMISSION FOR SCHEDULED TRIBES

Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Dilkusha Guest House, Hyderabad in the case of Shri Gajula Raghu and other tribal residents of Gowlidoddi hamlet under Gopanpally Gram Panchayat regarding forceful eviction by revenue officials.

Shri Gajula Raghu and other tribal residents of Gowlidoddi hamlet under Gopanpally Gram Panchayat, Serilingampally Mandal, Ranga Reddy District, vide their representation dated 16.07.2025, have alleged that they have been illegally and forcefully evicted by revenue officials and over 300 police personnel on 08.12.2021 without any prior notice, despite residing in Basavataraka Nagar, Survey No. 37, for 45 years. They claimed that their houses were demolished on the pretext of government land allotment to IT companies, and when they protested, 80-90 people including women and children were detained. Despite the Telangana Human Rights Commission's order dated 27.12.2021 and a status quo order by the Telangana High Court, attempts to evict them continued. Recently, a former corporator allegedly coerced families to vacate by offering ₹3 lakhs and obtaining thumb impressions on blank papers, leading to the demolition of vacated homes. On 09.07.2025, goons allegedly backed by police attacked residents, looted valuables, and filed false FIRs against them. The petitioners seek Commission's intervention for protection from police and revenue officials, restoration of basic amenities, and issuance of land pattas in Survey No. 37 where they have lived for decades.

- 2. The Commission issued notice to the Collector & District Magistrate, District- Ranga Reddy and Deputy Commissioner of Police, Ranga Reddy vide NCST letter dated 31.07.2025 seeking facts and comments within 05 days.
- 3. Reply was not received hence the Commission has decided to discuss the issue with the authority and the petitioner on 29.08.2025. Accordingly, a Sitting Notice was sent on 20.08.2025.
- 4. The petitioners have attended the hearing. The Deputy Collector, Serilingampally has attended on behalf of the District Collector, Rangareddy District.
- 5. The petitioners informed that they were on the said land since 1982 and have reiterated the plea and have produced the evidences of assurances made by the public representatives, the orders of Hon'ble High court and Human rights commission and also approval for sanction and plan for construction of flats under JNNURM scheme in the said land in 2009.
- The authority has informed that originally as per the Khasra Pahani for the year 1954-55, the name of Toli Mahadev has been recorded as pattadar in respect of survey No.37 admeasuring Ac.8.00 Gts situated at Gopanpally village. After his demise of pattadar Sri. Toli Mahadev, his son's name of Sri.Siddoba has been recorded in the revenue records. Late Siddhobha have executed sale deed in favour of Amancherla Narasimha Rao who developed the said land into a residential layout in 1972 itself. Sri Amancherla Mallikarjuna Rao who is sthe son of purchaser Sri. Amanacherla Narasimha Rao has filed application seeking deletion of the land in survey no.37 from list of prohibitory property U/s 22-A of Registration Act and issue NOC. CCLA has permitted the same and revenue authorities have proposed for deletion from the list of Prohibitory property in favor of Sri.a.Mallikarjuna Rao. Accordingly as per the orders passed by the Hon'ble Supreme court and clearance from the revenue authorities, the applicant was trying to vacate the said huts erected by petitioners and other sin the proposed land with amicable negotiations and some of them removed the said huts themselves while some others protested and hence the RDO, Rajendranagar promulgated orders for taking over the physical possession of the said land into Government custody until further orders. In pursuant to the orders, the subject land has been taken into Government cstody by Mandal Girdawar, Serilingampally Mandal under section 164 of BNSS Act under cover panchanama on 11.7.25. There after Sri. M.Gangadhar and 8 others have enetered into the subject land, which has already been taken into Governemnt custody under section 164 of BNSS Act

- 7. The ACP, Madhapur Division has informed that on 9.7.25 on receipt of 100 Dial call the police visited the place of incident and registered 2 cases on the petitions received from Smt Khaja Bee and Sri Mohammed Rafi and upon the enquiry it is revealed that the disputes on said parcel of land are longstanding in nature involving counter claims by private land owners and residents and considering the unstable situation an likelihood of breach of peace on 10.7.25 the inspector of Police, Gachibowli has addressed a letter to the Revenue Divisional officer to initiate proceedings under Section 164 BNSS and accordingly the RDO has issued necessary orders vide Order No.D/1566/2025 Dated 11.7.25.
- 8. After hearing to the petitioner and authorities the following recommendations are made and the ATR may be submitted in 30 days time.
 - a. Detailed investigation may be made as from how many years the petitioners are in possession of the said land with proofs of Aadhar, Residential proofs, Ration cards, Tax details etc.
 - b. It may be explained as to why without the issuance of vacate notice the huts were demolished and forceful evacuation is made when the petitioners are residing there peacefully for several years. c. Status quo may be maintained.
 - d. The CCLA, District Collector and CP, Cyberabad may attend the next scheduled date of hearing with detailed reports.
