### NATIONAL COMMISSION FOR SCHEDULED TRIBES

Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Dilkusha Guest House, Hyderabad in the case of Shri Munavath Venkatesh, Proprietor of M/s Hari Hara Readymade Garments (9848348909) regarding harassment by the Bank management by issuance of Auction Notices for sale of his property.

Date of the Sitting: 28/08/2025, 1.00 PM Participants in the Sitting: As per Annexure NCST/DEV-4277/TS/1/2025-RU-III

Shri Munavath Venkatesh, Proprietor of M/s Hari Hara Readymade Garments, vide his petition dated 07-01-2025, has stated that he and others, as absolute owners of a property in Waddepally, Hanumakonda District, entered into a sale agreement on 23-08-2017 with Khaja Tajul Abideen for ₹90,00,000, but received only ₹2,00,000, with the remaining amount to be paid through cheques. The agreement stipulated that if the cheques were dishonored, the sale deed would be null and void, but the purchaser failed to make payments, and all cheques bounced. Later, the petitioner discovered that the purchaser had taken a ₹50,00,000 loan from Union Bank, Chikkadpally by pledging the property's title documents with M/s Sharief & Co. Despite paying ₹45,00,000 to recover the documents, the bank officers are now refusing to return them. He sought the Commission's intervention for investigation, action, and retrieval of his property documents.

- 2. In the sitting held on 24.05.2025, the Commission recommended the following"a. Shri.Munavath Venkatesh may file a case on the person who has cheated him as he has the proofs of check bounce. If shown as proof there is a possibility of recording that transaction as null and void. b. Till the PS registers the FIR, No further notice may be issued by the Bank asking to vacate. c. Debts Recover Tribunal (DRT) may be requested by the bank not to proceed. d. The petitioner may ensure that the contradicting claim cases filed by his family members in DRT are addressed."
- 3. ATR has not been received. Meanwhile the Bank continued issuing the Notices and hence the Commission decided to discuss the issue with the authority and the petitioner on 28.08.25. Accordingly, a Sitting Notice was sent on 22.08.2025.
- 4. The Petitioner Munavath Venkatesh has attended the hearing. On behalf of the authority the General Manager, Mumbai has attended the sitting along with the local bank staff.
- 5. The petitioner reiterated his plea. The authority has informed that they are taking action as per the banks rules and regulations and as per the documents he is not the owner though contradictory claims are made before the DRT by this family members and also informed that the petitioner is free to participate in the public auction or to opt private treaty to protect his interests.
- 6. After hearing to the petitioner and authority the following recommendations are made and ATR may be submitted in 15 days from the receipt of the Minutes.
  - a. The bank may examine the option to finalise the OTS with Rs.65 lakh on humanitarian grounds considering the vulnerability of the petitioner.

b. Otherwise, The DRT may hold the auction till the case is decided by the NCST.

c. The authority ie, MD, Union Bank may attend to the next scheduled date of hearing.

d. The Recovery officer, DRT-I, Hyderabad may attend to the next scheduled date of hearing with necessary documents.
