NATIONAL COMMISSION FOR SCHEDULED TRIBES

Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Dilkusha Guest House, Hyderabad in the case of Dr. Bhukya Chander Nayak, Associate Professor, GMC Siddipet and IMA President, Siddipet District regarding implication in false cases by police officials.

Dr. Bhukya Chander Nayak, Associate Professor, GMC Siddipet and IMA President, Siddipet District, vide his petition dated 06.04.2025 has alleged that the police officials of Mustabad Police Station, Rajanna Sircilla District, Telangana have falsely implicated him and members of the Lambadi community in criminal cases, resulting in wrongful arrest and 15 days of judicial custody. He has accused Sub-Inspector Mr. Chindam Ganesh of using abusive, casteist language and of misusing his authority to harass and intimidate members of the Scheduled Tribe community. He stated that the incident caused mental trauma, social humiliation, and has left the community in fear of further harassment. He has requested the Commission to order a detailed inquiry, take strict disciplinary and legal action against the official, withdraw the false cases, and provide protection to the community from further abuse.

- 2. Superintendent of Police, Rajanna Sircilla District, vide his letter dated 15.05.2025 has informed the Commission that the complaint filed by Dr. Bhukya Chander Naik alleging caste discrimination and harassment by SI Ch. Ganesh was found to be false and fabricated upon enquiry. He stated that the petitioner's brother, Bhukya Ravi, and others were arrested in a theft and extortion case (Cr. No. 50/2025), and when the petitioner visited the police station, he allegedly argued with the SI and obstructed official duties, leading to a case (Cr. No. 75/2025) being filed against him. It was found during the enquiry that the SI did not humiliate or assault the petitioner, and that the complaint was lodged with a predetermined mind. Hence, the Superintendent of Police concluded that no further action is required in the matter.
- 3. Thereafter, sittings were scheduled on 06.05.2025, 17.06.2025, 24.06.2025 and 18.07.2025 but were not held due to non-presence of authorities. The Commission has again decided to discuss the issue with the authority and the petitioner on 29.08.2025. Accordingly, a Sitting Notice was sent on 20.08.2025.
- 4. The petitioner Dr Bhukya Chander Naik has attended the hearing. The Deputy Superintendent of Police and Sub-Inspector has attended the hearing on behalf of the District Superintendent of Police, Rajanna Siricilla.
- 5. The petitioner has informed that on 11.3.25 when the police has arrested his brother Bhukya Ravi and Redyanaik in a false robbery case which is infact fabricated after a dispute with the villagers. He approached the Mustabad PS and questioned the SI to know about the reasons for arrest and thereafter he was humiliated for no reason and was confined in the PS from 12.30 PM in the afternoon to 9.00 PM in the night. The authority has informed that the petitioner has obstructed the official duties of the Sub inspector and has misled the case.
- 6. After hearing to both the petitioner and authority, the following recommendations are made and ATR may be submitted in 30 days of time.
 - i. The Call data record (CDR) from 21st Febraury 2025 to 11th March 2025 of both the parties may be examined to arrive at the conclusion whether any preplanned attack was hatched by the villagers belonging to BC and SC communities intentionally.
 - ii. The detailed CC TV Footage in the PS on the day of custody of the petitioner may be produced to NCST. iii. The District SP may conduct the detailed enquiry on the allegations made on the said Sub inspector of Mustabad.
 - iv. The District SP may attend before NCST in the next scheduled date of hearing.
