

Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Shri Nenavat Komati, Venkatitanda, Devenrakonda Mandal, Turupu Palle, Nalgonda District regarding denial to issue the National Livestock Mission Scheme by the State Bank of India.

Smt. Nenavat Komati, Venkatitanda, Deverakonda Mandal, Nalgonda District vide her representation dated 22.05.2025 has stated that she was denied issuance of the National Livestock Mission (NLM) scheme by the State Bank of India, Devarakonda Mandal, Nalgonda District. She alleged inconsistent information from bank officials, as Field Officer Prashant initially assured her after site inspection but later denied eligibility citing agricultural land, while Senior Manager Sanyasi Raju contradicted this. She further stated that Shri Prashant used unparliamentarily words against her community. She has requested the Commission to intervene, direct SBI to review her application, provide clear reasons for denial, sanction the scheme if eligible, and ensure transparency and consistency in processing applications.





2. The Commission issued notice to the Chairman and Managing Director, State Bank of India vide NCST letter dated 13.06.2025 seeking facts and comments within 30 days. The reply was not received from authority, hence, NCST has decided to discuss the issue with the authority and the petitioner on 24.07.2025. Accordingly, a Sitting Notice was sent on 16.07.2025.

3. In the sitting, the General Manager - II, SBI, Hyd. Circle along with Sr. officer of SBI were present. The petitioner joined via phone. The petitioner has reiterated her earlier submission and requested for justice. The officers of SBI informed that the matter was inquired on the allegations leveled by petitioner. It has been found that the official of SBI has not misbehaved with petitioner. It was informed that the supporting documents submitted by petitioner for obtaining the benefits of National Livestock Mission (NLM) scheme were incomplete. However, the SBI officers have been advised to cooperate with the customers. Now, the petitioner is required to submit the documents on portal for benefit of NLM scheme which is governed by Govt. of India. There is no role of SBI. The SBI role will be start as and when complete application received through online portal of NLM scheme. The SBI will consider the application of petitioner, as and when received through online portal.

4. After discussion with the officer and petitioner, it was observed that there is no fault on part of SBI. The petitioner is advised to upload his application on portal for availing the benefits of NLM scheme. The SBI local Head Office, Hyderabad is also advised to initiate the action on the application of petitioner, on priority basis.
