## NATIONAL COMMISSION FOR SCHEDULED TRIBES

Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Dilkhusha Guest House, Hyderabad in the case of Shri S. Anjineyulu Naik, AP State President, Akhila Bharat Banjara Seva Sangh (ABBSS) regarding alienation of lands of ST residents belonging to various villages in Nallamada Mandal, Sri Sathya Sai District.

Shri S. Anjineyulu Naik, AP State President, Akhila Bharat Banjara Seva Sangh (ABBSS), vide his representation dated 9.4.2025 has stated that a large group of ST residents belonging to various villages in Nallamada Mandal, Sri Sathya Sai District, Andhra Pradesh are absolute owners and cultivators of approximately 180 acres of agricultural land, which they have possessed and cultivated for the last 40 to 50 years. They claim to have Pattadar passbooks and Adangals issued in their names and have taken agricultural loans based on these lands. However, they allege that one Sane Ravindra Reddy has filed cases before the Revenue Divisional Office, Kadiri, and the High Court of Andhra Pradesh and obtained favorable orders for mutation and title deeds in his name concerning their lands. The petitioners, mostly illiterate and unaware of legal procedures, fear imminent removal of their names from revenue records, resulting in loss of livelihood and extreme hardship. They seek the Commission's intervention and enquiry to protect their rights and titles over the said lands.

- 2. The Commission issued notice to the Collector & District Magistrate, Sri Sathya Sai District vide NCST letter dated 02.05.2025 seeking facts and comments within 30 days.
- 3. No reply was received from the authority. Hence the Commission decided to discuss the issue with the authority and the petitioner on 11.08.2025. Accordingly, a Sitting Notice was sent on 02.08.2025. In the sitting, RDO, Puttaparthi attended on behalf of the District Collector and the petitioner was personally present.
- 4. The petitioner has informed that STs of 4 villages -N.Badavandlapally, Basamvaripally, Aravandlapally Thanda, Pemanakuntapally Thanda, Kondravaripally in Revenue Survey Numbers 589,590,591, 598, 599, 600 are affected by this dispute and it is turning to new shades due to political involvement.
- 5. The authority has informed that the investigation is still under process and it may take 15 days to conclude. It.
- 6. After discussion with both the petitioner and authority the following recommendations were made. The ATR may be submitted within 30 days from the receipt of Minutes.
- I. RDO may conduct a detailed field enquiry and verification and if needed a Gram sabha may be conducted for authentication of the claim of the petitioners and the opponent.
- II. Police Protection may be given to petitioners and to ST Farmers in occupation of said lands in view of the threatening calls of the opponent against the petitioners.
