Minutes of the sitting held under the chairmanship of Dr. Asha Lakra, Hon'ble Member NCST on 05.08.2025 at Lok Nayak Bhawan, Khan Market, New Delhi regarding appeal for seeking intervention regarding re-consideration for employment under compassionate ground in Chittaranjan Locomotive Works (CLW) (Indian Railway) in respect of Shri Hemal Tudu son of late Shri Bodilal Tudu.

Date and Time of Sitting: 05.08.2025 at 01:00 pm

Shri S.C. Brahama, Zonal Secretary, All India SC/ST Railways Employees Association, Paschim Bardhaman (West Bengal), vide his letter dated 13.05.2025, appealed to the Commission seeking intervention for reconsideration of compassionate appointment in Chittaranjan Locomotive Works (CLW), Indian Railways, in respect of Shri Hemlal Tudu, son of late Shri Bodilal Tudu. It was further stated by Shri Brahama that Shri Hemlal Tudu has acquired the requisite educational qualification (Class X) for such appointment.

2. Taking cognizance of the petition, the Commission issued a notice dated 20.06.2025 to the General Manager, Chittaranjan Locomotive Works, seeking facts and comments within 15 days. However, as no satisfactory response was received, the matter was listed for sitting on 05.08.2025. A notice of sitting was accordingly issued to the General Manager, CLW, with a copy endorsed to the petitioner.

3. During the sitting, the General Manager, CLW, was not present. The organisation was represented by the Chief Personnel Officer and the Assistant Personnel Officer. The representatives submitted before the Commission that the case of Shri Hemlal Tudu for compassionate appointment is under active

consideration and that the issuance of the appointment letter is in process and expected to be finalized shortly.

4. After due consideration of the submissions made and sitting the parties concerned, the Commission makes the following recommendations:

1. The Chittaranjan Locomotive Works administration shall finalize the case within **30 days** and issue the appointment letter to Shri Hemlal Tudu without any further delay.
2. A copy of the appointment letter shall be forwarded to the Commission for its records and necessary follow-up.
3. The Commission will continue to monitor the matter until its satisfactory resolution.
