Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Shri Kora Narsimhamurth, Founder President Adivasi Navanirman Sena, Mulugu District, Telangana regarding threatening of Adivasis and encroachment of their land by non-Adivasis.

Shri Kora Narsimhamurthy, Founder President, Adivasi Navanirman Sena (ANS), Mulugu District (Telangana) vide his representation dated 21.06.2024 has stated that 28 ST families of Ontimamidi village, Venkatapuram Mandal, Mulugu District were assigned 54 acres of land in Survey Nos. 11, 22 and 28 of Bandaripalli Revenue Village in the year 2001 and were issued Pattadar Passbooks. However, some non-ST persons from Besta Gudem village are obstructing them from cultivating the land and are harassing them by lodging false cases and issuing threats. Hence, do the justice.

2. The Commission issued notice to the District Collector & Magistrate District Mulugu and Superintendent of Police, District- Mulugu on 18.02.2025 for seeking facts and comments within 30 days from receipt of the Notice.

3. The Superintendent of Police, Mulugu District, vide letter no. 1975/G1-MLG/2025 dated 02.04.2025 has informed that an enquiry was conducted regarding obstruction by non-ST individuals in cultivating assigned lands in Survey Nos. 11, 22, and 23 of Bandari Palli village. The enquiry revealed that no prior complaint was received by the police concerning the alleged land dispute, which appears to be of civil nature. However, it was assured that any future complaint will be acted upon immediately and cases under SC/ST (PoA) Act would be registered against illegal encroachers. The report further states that steps are being taken to prevent illegal land transfers in Scheduled Areas and to implement Koneru Ranga Rao Committee recommendations and coordinate with other departments for enforcement. The situation is reported as peaceful and the authorities are committed to safeguarding government and ST lands through legal measures and surveillance.

4. The Collector, Mulugu District, vide letter no. E2/190/2025 dated 06.05.2025 has informed that an enquiry was conducted on the issue of illegal constructions and violation of PESA and 1/70 Acts. It was informed that a Land Transfer Regulation case was already filed and a hearing has been conducted. On diversion of ST Sub-Plan funds, mining permissions and non-implementation of the Forest Rights Act, the Project Officer, ITDA reported that PESA and 1/70 Acts are being followed, mining is permitted only after Gram Sabha approvals, and Tribal Sub-Plan funds are being appropriately utilized. On the issue of land encroachments in Sy. Nos. 11, 22, 23 of Bandaripalli village. The RDO and Tahsildar reported that the land is government land assigned to STs and an interim injunction in favour of tribals has been granted by Mobile Court, Bhadrachalam. Preventive action has been taken by the police and protection ensured. It is stated that necessary legal and administrative actions have been taken and the District Administration is committed to protecting the rights of STs. Hence, it is requested to close the case. Hence, NCST has decided to discuss the issue with the authority and the petitioner on 08.08.2025. Accordingly, a Sitting Notice was sent on 29.07.2025.

5. In the sitting, the District Collector, Mulugu District and SP, Mulugu were present. The petitioner joined via phone. The petitioner has reiterated his earlier submission and requested for justice. The Collector and SP, Mulugu District had also reiterated their comments and stated that the District Administration is committed to protect the rights of STs and out of 56 acres of disputed land, the 50 acres is already settled and STs are in occupation and the remaining 6 acres of land will also be surveyed shortly and brought to a logical conclusion.

6. After discussion with the officers of District Administration of Mulugu and petitioner, it was observed that no action is warranted on part of NCST, however the District authorities are advised to settle the claim of the STs at the earliest and ensure that there is no tribal land alienation.





