## NATIONAL COMMISSION FOR SCHEDULED TRIBES

Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Shri Banoth Praveen Lal, Social Security Assistant (SSA) EPFO, Nizamabad regarding under reporting of vacancy for ST category for Examination Quota

NCST/SER-2180/MFIN/13/2025-RU-III Date of the Sitting: 7/08/2025, 8:00 PM Participants in the Sitting: As per Annexure

Shri Banoth Praveen Lal, Social Security Assistant (SSA), EPFO, Regional Office, Nizamabad, vide his petition dated 17.03.2025, has alleged incorrect calculation of vacancies under the ST category for promotion to the post of Section Supervisor through the Limited Departmental Competitive Examination (LDCE). He states that against the required 7 ST vacancies under the Examination Quota (EQ) for Telangana (as per DoPT norms and a cadre strength of 135), only 6 were notified by EPFO Zonal Office, Telangana, resulting in the denial of one promotional opportunity. He contends that he had qualified on merit and was placed second among ST candidates but was denied promotion due to this shortfall. He further questions the role of the liaison officer for STs, alleging failure in ensuring proper reservation compliance. Hence, do the justice.

- 2. The Commission issued notice to the Central Provident Fund Commissioner, Employees Provident Fund Organization, New Delhi on 07.04.2025 seeking facts and comments within 30 days from receipt of the Notice.
- 3. The EPFO vide letter no. A-45011/37/2025-HRM-III dated 16.05.2025 has furnished the facts and stated that at present the petitioner is posted as Sr. Social Security Assistant at Regional Office, Nizamabad and not promoted to the post Section Supervisor as mentioned his designation in the representation. Further, it was informed that as per roster calculation methodology under DoPT's O.M. dated 02.07.1997, only whole numbers are considered for reservation points—hence, 6 ST vacancies (not 7) were validly allotted against the Examination Quota for a roster size of 90 posts in Telangana Zone. Accordingly, 2 ST candidates were selected in the LDCE held on 22.11.2024 and petitioner being 3rd in ST merit list was not promoted. There is no change in the position in the category of SC and ST after finalizing of the rosters. This letter was sent to the petitioner, vide NCST letter of even no. dated 03.06.2025.
- 4. The petitioner vide his rejoinder dated 23.06.2025 has refuted the facts and comments and requested for justice. Hence, NCST has decided to discuss the issue with the authority and the petitioner on 07.08.2025. Accordingly, a Sitting Notice was sent on 29.07.2025. The Commissioner, EPFO vide letter dated 1.8.2025 has sought exemption and deputed ACC (HR) and RPFC-I and Liaison Officer for SC/ST, EPFO (HQ), New Delhi.
- 5. In the sitting, the above officers from EPFO and petitioner were present The petitioner has reiterated the issues and points raised in the rejoinder dated 23.6.2025 and stated that EPFO had not followed the DoPT rules in respect of reservation for STs in the said post. The officers of EPFO reiterated the facts submitted by EPFO vide letter dated 16.5.2025 and stated that the sanctioned strength of Section Supervisors for the Telangna Zone is 135. As per the provisional anticipated rosters as on 31.12.2024, the roster size under Examination and Senority quota is 90 and 45, respectively. The vacancies under EQ are higher as these posts were not filled up in past.
- 6. After discussion with officers of EPFO and petitioner, the following recommendations were made and action taken thereon may be submitted within 30 days from receipt of the minutes.

The roster for examination quota and Seniority quota may be rechecked.

As the combined representation of 10 for ST is well within the prescribed percentage of reservation of 7.5% of sanctioned strength of 135 of the post of SS and as there is less representation of STs by 1 post, the no. of posts reserved for ST in EQ cadre calculated at 6 for purpose of notifying the vacancies may be revised to 7, resulting in one additional vacancy of ST in the year 2024, to which the petitioner may be promoted based on the results of the LDCE examination in accordance with the existing rules.

The TA & Special Leave may be reimbursed / granted by PH & ME Department, Hyderabad in

favor of the petitioner, as per entitlement.

An Internal Grievance Redressal Committee fto look after the grievances of ST employees may be set up in the organization, as suggested by NCST in Aug, 2021 to all Ministries/ Departments.

The Liaison Officer may be nominated from ST category in the Regional Offices.
