Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Sri E. Kanniyappan, Tiruvavannamalai District (Tamilnadu) regarding allocation of free house site patta for scheduled tribes (ST) of Irular community.

Shri E. Kanniyappan, a resident of Kunnagampoondi, Vandavasi Taluk, Tiruvannamalai District vide his petition dated 16.09.2024 has raised concerns regarding the non-allocation of free house site pattas to the Irular community (Scheduled Tribes) by the Govt. of Tamil Nadu in the District. He stated that despite submitting grievance petitions to the District Collector on 30.06.2014 and to the Chief Minister's office through Lr.No.46083/N.M.1(1)/2021-1 dated 06.01.2022, no action has been taken and the Tahsildar of Vandavasi has not initiated any inquiry in the last two years. He alleged delay in Patta allocation, lack of transparency, corruption involving middlemen and inadequate awareness about the schemes among ST members. He has requested urgent intervention of the Commission to ensure timely and transparent distribution of house site pattas to the eligible Scheduled Tribe families in the District.

- 2. The Commission issued notice to the Collector and District Magistrate, Tiruvannamalai District and the Director, Directorate Of Tribal Welfare, Tamil Nadu on 01.01.2025 seeking facts and comments within 30 days from receipt of the Notice. The reply was not received, hence, NCST has decided to discuss the issue with the authorities and the petitioner on 05.08.2025. Accordingly, a Sitting Notice was sent on 28.07.2025.
- 3. In the sitting, the District Collector, Tiruvannamalai District and petitioner were present. The petitioner reiterated his earlier submission and stated that the District Administration has not taken action to issue the patta for house sites in his favour. The District Collector, Tiruvannamalai District has provided their letter bearing no. 24/2025/A1 dated 4.8.2025 and stated that the District Administration is addressing the needs of PVTG and continuously creating awareness regarding various welfare schemes implemented by the State Government and Government of India. As per Govt. of Tamil Nadu rules free house site pattas are not allowed to beneficiaries or any of the family member serving Government Job. Hence, the petitioner is not entitled for free house site pattas because he was Government employee, where as the free house site patta is issued in favour of his father.
- 4. After discussion with the District Collector, Tiruvannamalai District and petitioner, it was observed that the no action is warranted on part of NCST in respect of the case of the petitioner for allotment of free house site patta. However, the District Administration and Tribal Welfare Department, Govt. of Tamil Nadu is advised the number of land less person of Irular ST community may be surveyed and action may be initiated to provide the land for house sites.
