Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of J Bhojya, Conductor, Barkarpura Depot, Telangana State Road Transport Corporation, resident of Plot No87, Laxmi Garden Colony Near Open Gym Park Turkayamjal 501510 Rangareddy Dist Telangana regarding reinstatement in service.

Shri J. Bhojya, Conductor (E.212633), Barkatpura Depot, vide petition dated 03.07.2025, has submitted that he has been wrongly removed from service based on vague and arbitrary charges relating to alleged cash and ticket irregularities on 24.05.2024. He claims that the enquiry report merely reproduced statements dictated by TTIs and not actual passenger accounts. He states that due to vomiting and ill health, he could not properly check tickets or IDs, which led to a lady passenger receiving a zero ticket without Aadhar verification. He further contends that in another charge, two male passengers did not actually pay him fare, contrary to the allegation. He requested for justice.

- 2. NCST issued notice to the Vice Chairman and Managing Director, Telangana State Road Transport Corporation on 15.07.2025 for seeking facts and comments within 7 days. The reply was not received, hence, NCST has decided to discuss the issue with the authority and the petitioner on 07.08.2025. Accordingly, a Sitting Notice was sent on 29.07.2025. The MD, TSRTC vide letter dated 1.8.2025 has deputed Regional Manager, Hyderabad Region and Depot Manager, Barkutpura depot for attending the sitting as the matter comes under their jurisdiction.
- 4. In the sitting, the above officers were present and petitioner joined through phone. The petitioner reiterated his submission and requested for justice. The officers of TSRTC have stated that the Department has taken action as per rule against the petitioner and there was no discrimination meted out with petitioner on caste basis. Further it is stated that the corporation functions on the trust of the employees and the revenue generated from the tickets is the sole source of income for the corporation on which the salaries of employee and future of the corporation depends.
- 5. It was observed that the management of TSRTC has taken very harsh step against the petitioner by removing him from service as at this age after serving.
- 6. After discussion with officers of TSRTC and petitioner, the following recommendations were made and action taken thereon may be submitted within 30 days from receipt of the minutes.
- The TSRTC Management may initiate action for reinstatement iof the petitioner, taking a lenient view on sympathetic grounds as he has served the corporation for significant time.
- The condition of the employees in the late hours especially in the last schedule of the buses where the passengers are almost double to the capacity of seating should have been taken into account as it would be difficult to verify the Aadhars and identity of each of the passengers at that time where passengers get irritated for the delay and usually do not cooperate. The version of the conductors should have been heard too rather than coming to a conclusion based on TTIs report on supposed misappropriation.
- Further a Standard operating protocol(SOP) for the conductors may be devised and implemented by sensitising the staff to avoid such incidences.
