## **NATIONAL COMMISSION FOR SCHEDULED TRIBES**

Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Shri Bukke Krishna Naik of Ummayipalle Thanda village of Kolimigundla mandal of Nandyal District regarding harassment by the Revenue officials in the land matter.

Shri Bukke Krishna Naik, resident of Ummayipalle Thanda, Kolimigundla Mandal, Nandyal District, has submitted a petition dated 22.09.2024 stating that his land in Survey Nos. 337 and 357, measuring a total of 8.25 acres was measured by the Mandal Surveyor and VRO as per the orders of the Tahsildar. However, he is in possession of only 7.20 acres and the remaining 1.05 acres has been allegedly encroached upon by Bhoi Erikalamma, Thalari Lakshmidevi, Golla Gavini Balayya and Y. Lakshmidevi. He further alleges that when he demanded restoration of his land, the encroachers attempted to assault him and earlier complaints to the MRO were ignored. He has requested the Commission to intervene and restore the encroached land to him at the earliest.

- 2. The Commission issued notice to the Collector and District Magistrate, Nandyal on 14.02.2025 for seeking facts and comments within 30 days from receipt of the Notice. The Collector & District Magistrate, Nandyal, vide letter no. B3/2189/2024 dated 12.07.2025 has informed the encroachment of patta land in Survey Nos. 337 and 357 in Thollamadugu Village, Kolimigundla Mandal was thoroughly enquired into by the Tahsildar and RDO. The land in question is part of a Hindu Undivided Family comprising legal heirs from two wives of late Bukke Chinna Balu Naik, and the petitioner belongs to the first wife's lineage. As per official records (RSR, ROR, Adangal, and online records), various family members, including the petitioner, are in enjoyment of portions of the said lands and some parts are under public use such as road and poramboke. After conducting due proceedings under the ROR Act and Survey Boundaries Act, 1923, the Tahsildar passed a final order, post which the petitioner expressed satisfaction and gave a written statement for voluntary withdrawal of his complaint from the Commission. The Collector has stated that there is no case of harassment by revenue officials and the matter stands resolved.
- 3. The Commission has decided to discuss the issue with the authority and the petitioner on 08.08.2025. Accordingly, a Sitting Notice was sent on 29.07.2025. The Collector and District Magistrate, Nandyal vide letter no. B3/2189/2024 dated 5.8.2025 has again communicated the facts and comments and sought exemption and deputed Tehsildar, Kolimigundla to attend the sitting. In the letter it has been stated that the notices has been issued to conduct ROR enquiry on 12.8.2025 to both the petitioner and opponent, further, under ROR Act, a speaking order will be passed accordingly.
- 4. In the sitting, the Tehsildar, Kolimigundla was present and petitioner joined via phone. The petitioner has reiterated his submission and requested for justice. The Tehsildar has reiterated the facts submitted by the Collector and District Magistrate, Nandyal vide letter dated 5.8.2025.
- 5. After discussion with the Tehsildar, Kolimigundla and petitioner, it was observed that no action is warranted on part of NCST. However, the District Administration is advised that the decision taken in the proposed meeting on 12.8.2025 under ROR Act may be furnished to NCST.
