Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Shri Y.Pedda Narsimulu, S/o Yellappa, R/o Pathapally Village, Dhanwada Mandal, Narayanpet District, Telangana State regarding issue of Pass Book in land bearing Sy.No.48 situated at Pathapally Village of Dhanwada Mandal, Narayanpet District.

Shri Y.Pedda Narsimulu, S/o Yellappa, R/o Pathapally Village, Dhanwada Mandal, Narayanpet District (Telangana) vide representation dated 29.06.2024 alongwith copy of the letter no. E2/1084/2019 dated 17.10.2022 of District Collector, Narayanpet regarding issue of Pass Book in land bearing Sy.No.48 situated at Pathapally Village of Dhanwada Mandal, Narayanpet District and requested for justice (In this regards it is mentioned that the NCST has taken up with the Collector and District Magistrate, Narayanpet, Telangana vide NCST communication no. YPN/15/2019/STGTL/DEOTH/RU-IV dated 22.10.2019 as well as RO, Bhubaneswar File No.32/01/2022-RU dated 15.09.2022.)

- 2. The NCST vide Notice on 2.4.2025 has again taken up the matter with the District Collector and Magistrate, Narayanpet for seeking facts and comments within 15 days from receipt of the Notice. The reply was not received, hence, NCST has decided to discuss the issue with the authority and the petitioner on 08.08.2025. Accordingly, a Sitting Notice was sent on 29.07.2025.
- In the sitting, the Collector, Narayanpet District was present and petitioner joined via phone. The petitioner has reiterated his submissions and requested for justice. The Collector, District- Narayanpet provided the letter no. E2/1084/2019 dated 7.8.2025 alongwith copy of earlier correspondence made with NCST. In the letter, it has been mentioned that Upon verification of records and as per the report of the Tahsildar Dhanwada dated 05.08.2025, it is submitted that the applicants' mother, Smt. Manemma W/o Yellappa, holds Ac. 2.05 gts of ceiling patta land in Sy. No. 123, situated within the same village limits. Presently, Sri Pedda Narsimulu is in possession of Ac. 5.00 gts of Government land in Sy. No. 74, while Sri Chinna Narsimulu is in possession of Ac. 2.33 gts of Government land in Sy. No.48. The wives of both applicants are employed in Government service and were earlier considered for assignment of land. However, as per the latest records, Smt. Renuka W/o Pedda Narsimulu has been working as Ward Officer, Municipal Office, Narayanpet, since 10.08.2023 drawing a salary of Rs. 32,736/- per month (i.e., Rs. 3,92,832/- per annum). Similarly, Smt. Swathi W/o Chinna Narsimulu is employed as Junior Assistant in the Tahsildar Office, Makthal, from the same date, drawing a monthly salary of Rs. 31,987/- (i.e., Rs. 3,83,844/- per annum). In view of the above and as per G.O.Ms.No.1406, Dt:25/07/1958 and subsequent Government instructions issued from time to time, Government land is assignable only to landless poor persons falling under the Below Poverty Line (BPL) category. Since both applicants' families have annual incomes above the BPL threshold and are gainfully employed in Government service, they do not qualify for assignment of Government land under the prevailing rules.
- 4. After discussion with the District Collector & Magistrate, Narayanpet and petitioner, it was observed that no action is warranted on part of NCST.
