## NATIONAL COMMISSION FOR SCHEDULED TRIBES

Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Dilkhusha Guest House, Hyderabad in the case of Smt. B. Prameela Bai, Office Subordinate, MRT Division, Ananthapuramu regarding denial of both service advancement and financial benefits for over six years by APSPDCL.

Smt. B. Prameela Bai, Office Subordinate, MRT Division, Ananthapuramu, vide her representation dated 07.11.2024, has stated that despite being listed at SI. No. 3 for transfer by appointment from General Services to the post of Junior Assistant as per Memo dated 23.12.2017, the process has not progressed. She has made several representations, including on 20.02.2023 and 14.02.2024, to the concerned authorities such as the Chairman & Managing Director, APSPDCL, and CE, HRD, APSPDCL, but no action has been taken. She submits that being from a poor Scheduled Tribe (Banjara) background and lacking influence, her case has been overlooked, resulting in denial of both service advancement and financial benefits for over six years. She has now requested the intervention of the Hon'ble Member, National Commission for STs, to ensure justice in her case and to address similar issues affecting other ST candidates in Andhra Pradesh.

- NCST vide notice dated 20.01.2025 sought facts and comments from the CMD, Southern Power Distribution Company of AP Ltd within 30 days.
- The Superintending Engineer, Operation, vide his letter dated 15.02.2025, has informed the Commission that Smt. B. Prameela Bai, initially appointed on compassionate grounds as Office Subordinate at MRT, Anantapuramu on 25.06.2014, had applied for appointment by transfer to the post of Junior Assistant after acquiring a B.Com degree. Although her name appeared at SI. No. 3 in a list of 36 eligible candidates, the process could not proceed due to oral instructions from the Corporate Office to withhold such transfers owing to staff shortages in subordinate and O&M roles post-bifurcation of Andhra Pradesh. Additionally, a rationalization exercise in 2022 found a surplus of Junior Assistant posts in Anantapuramu Circle, further preventing any such appointments. Consequently, her case was not considered, and no appointments by transfer to Junior Assistant have taken place in Anantapuramu Circle to date. This was forwarded to the petitioner vide NCST letter dated 16.04.2025.
- The Commission decided to discuss the issue with the authority and the petitioner on 12.08.2025. Hence a sitting notice was sent on 02.08.2025. The Petitioner is represented by her Husband Shri Thirupal Naik has attended for the hearing. SE, Operations, APSPDCL has attended the hearing on behalf of the authority.
- The petitioner, Smt. B. Prameela Bai, Office Subordinate, MRT Division, Ananthapuramu, 5. represented by her husband Shri Thirupal Naik has stated that despite being listed at SI. No. 3 for transfer by appointment from General Services to the post of Junior Assistant as per Memo dated 23.12.2017, the process has not progressed. Though several representations, including on 20.02.2023 and 14.02.2024, to the concerned authorities such as the Chairman & Managing Director, APSPDCL, and CE, HRD, APSPDCL, are made no action has been taken and her case has been overlooked, resulting in denial of both service advancement and financial benefits for over six years.
- The authority has informed the Commission that Smt. B. Prameela Bai, initially appointed on 6. compassionate grounds as Office Subordinate at MRT, Anantapuramu on 25.06.2014, had applied for appointment by transfer to the post of Junior Assistant after acquiring a B.Com degree. Although her name appeared at SI. No. 3 in a list of 36 eligible candidates, the process could not proceed due to oral instructions from the Corporate Office to withhold such transfers owing to staff shortages in subordinate and O&M roles post-bifurcation of Andhra Pradesh. Additionally, a rationalization exercise in 2022 found a surplus of Junior Assistant posts in Anantapuramu Circle, further preventing any such appointments. Consequently, her case was not considered, and no appointments by transfer to Junior Assistant have taken place in Anantapuramu Circle to date.

to the Junior Assistant.

The CMD, APSPDCL may submit a detailed report on the implications of such ban with regard to the prospects of ST employees under the jurisdiction of APSPDCL.
