Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Shri Munavath Narshima Nayak, S/o Bhojya, R/o Ganesh Kunta Thanda, Warangal District, Telangana regarding allocation and demarcation of plot.

Shri Munavath Narshima Nayak, S/o Bhojya, R/o Ganesh Kunta Thanda, Warangal District, Telangana, belonging to the ST Lambada community and below poverty line, vide his petition dated 21-02-2025, has requested to direct the authorities to allot and demarcate his plot measuring 500 sq. yards in Sy. Nos. 37–40 at Gachibowli Village, Ranga Reddy District, as allotted by the Mobile Welfare Society (Regd. No. 2088/1991). He states that in 1991, land was allotted to landless poor by the then Collector through patta certificates for constructing old age homes and other welfare purposes. The society completed all formalities, including payment to the Revenue Department, and issued pattas and ID cards to 1800 beneficiaries. However, when he and 22 other ST beneficiaries attempted to occupy their plots, they were prevented by local police and threatened by realtors allegedly in collusion with officials, who denied their ownership and used casteist language. He alleges that plots were allotted to people from other castes who now occupy them, while ST beneficiaries face threats and denial of rights. He seeks intervention for demarcation and possession of the allotted land and protection from threats.

- In the sitting held on 05.05.2025, the following recommendations were made and action taken there on may be submitted to NCST within 30 days from the receipt of the minutes. The minutes was sent on 16.6.2025.
- A detailed enquiry may be made by a senior officer of Revenue Department as it is alleged that only the STs are not allowed in the said land and all others like Phoenix group, Deloitte etc have made constructions in the said land."
- 3. The Action taken report was not received, hence, NCST has decided to discuss the issue with the authority and the petitioner on 08.08.2025. Accordingly, a Sitting Notice was sent on 31.07.2025. The District Collector & Magistrate, Rangareddy vide letter dated 3.8.2025 has sought exemption and deputed RDO, Rajendra Nagar Division to attend the sitting.
- 4. In the sitting, the RDO, Rajendra Nagar Division and petitioner were present. The petitioner reiterated his earlier submissions and requested for justice. The RDO, Rajendra Nagar Division provided a letter no. C1/NCST/1290/2025 dated 5.8.2025 of District Collector & Magistrate, Rangareddy, which contains the facts and comments. In the letter it has been mentioned that "the then District Collector, Rangareddy District vide Lr No. E1/3069/2013 Dt.04.07.2013 has clearly stated that the alleged the Patta Certificate bearing No.D/06371/DA/SW/LA/91 dt. 31.12.1991 stated to have been issued in favour of Mobile Welfare Society, have not been issued by their office. Hence it is clear that the said Patta Certificate is found bogus & fabricated one and also several Criminal Cases have also been registered in the matter against the delinquents. Keeping view of the facts narrated above, the claim of the petitioners herein who are stated to be subsequent allotees by Mobile Welfare Society, to occupy the said lands is not considerable on the grounds explained above and the contention of the petitioners is only the STs are not allowed in the said land and all others like Phoenix group, Deloitte etc have made constructions in the said land, is not correct. The allegations made by petitioners is not maintainable and deserves no consideration."
- 5. After discussion with the RDO, Rajendra Nagar Division and petitioner, the following recommendations were made and action taken thereon may be submitted to NCST within 30 days from receipt of the Minutes.
- It is observed that the WPs 22145 of 2024 and 33499 of 2024 relating to this case are pending for adjudication in Hon'ble High Court of Telangana. Hence as it is sub-judice no further action is warranted on part
- However it is advised that the docments claimed to be as genuinely issued by the then District Collector, Rangareddy may be sent to Foresnic science labortaory for authentication and to ascertain the genuineness.
