Shri Bhukya Balam, aged 50 years, resident of Jagnathanda, Bayyaram Mandal, Mahabubabad District, Telangana, belonging to Lambada Scheduled Tribe community, vide his representation dated 24/05/2025 has stated that he surrendered in 2004 under the Government's Surrendered Extremist Rehabilitation Scheme with the assurance of being allotted 5 acres of agricultural land, but despite fulfilling all requirements and obtaining favorable departmental reports, he has not received the land for over 20 years, while others in the same scheme have been allotted land and are cultivating for livelihood. He has further alleged targeted discrimination on account of his ST status, harassment by officials, repeated delays, and false implication in cases, causing mental agony, health issues, and financial distress to his family.

2. NCST vide notice dated 16.06.2025 sought facts and comments from the Collector and DM, Mahabubabad within 30 days. However as the reply is not received Commission has decided to discuss the issue with the authority and the petitioner on 28.08.2025. Accordingly, a Sitting Notice was sent on 13.08.2025.

3. The Petitioner Bhukya Balam has attended over phone. RDO, Mahabubabad has attended on behalf of the authority ie, District Collector, Mahabubabad.

4. The petitioner reiterated his plea. The authority has informed that the evidences and documents are being examined by the Police Department after which the necessary action would be taken.

5. After hearing to the petitioner and authority the following recommendations are made and ATR may be submitted in 15 days from the receipt of the Minutes.

a. The verification of Police Department may be expedited and allocation may be made as per the assurance made Government's Surrendered Extremist Rehabilitation Scheme on par with others who have availed benefits under the scheme.


