NATIONAL COMMISSION FOR SCHEDULED TRIBES

Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Dilkusha Guest House, Hyderabad in the case of Shri Vislavath Ashok Room No. 20, Sports Hostel, Ou Campus, Osmania University, Tarnaka, Hyderabad regarding encroachment of assigned land by Mr. Bandaru Yadiah.

Date of the Sitting: 28/08/2025, 3.40 PM Participants in the Sitting: As per Annexure NCST/ATY-2338/TS/321/2025-RO-BHUV/RU-III

The petitioners, A. Bhadra and E. Soundarya, have stated that they have constructed houses on 75 Sq. Yards of land assigned and allotted to them, but one Mr. Bandaru Yadiah has been threatening to demolish the houses using fake documents. Despite multiple representations to the authorities, there has been no response or action taken in the matter.

- 2. In the sitting held on 15.05.2025, the Commission recommended that The land under occupation by Shri Yadiah may be renounced by the Revenue Department as the assigned land is not supposed to be encroached or purchased by the other party and the police Department may take immediate necessary action on the threats being faced by the petitioners especially with land relating to the Sevalal temple.
- 3. As the ATR has not been received, the Commission decided to discuss the issue with the authority and the petitioner on 28.08.2025. Hence a sitting notice was sent on 13.08.2025.
- 4. The petitioner Shri Ashok attended the hearing and the authorities ie, District Collector, Medchal Malkajgiri, Tahsildar, Medipally and Superintendent, Tahsildars office have attended the hearing.
- 5. The petitioners have reiterated their plea and the authorities have mentioned that the petitioners have been assigned the land by Government as part of Dasabdi Utsavalu, however they have sold executed notarized deeds in favor of Bandaru Yadiah who has inturn applied for regularization of the same by paying requisite fee under GO 58.
- 6. After hearing to the petitioner and authority the following recommendations are made and ATR may be submitted in 15 days from the receipt of the Minutes.
 - a. A circular may be issued that the notarized deeds are not valid and they are null and void as the said land is the assigned land.
 - b. Necessary action may be taken by the Revenue authorities with regard to the Court cases pending on the said land.
