## **National Commission for Scheduled Tribes**

Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Dilkhusha Guest House, Hyderabad in the case of Smt. Dungavath Chandrakala, W/o D. Ramesh Naik, regarding request for review of the Acquisition Order.

Smt. Dungavath Chandrakala, M/s Nikhil Filling Station, located at Sy. No. 336, Malkavemula Village, Mudigubba Mandal, Sri Sathya Sai District, vide her representation dated 25.1.2025 has alleged that NHAI has proposed land acquisition for the construction of the New Greenfield Expressway. In the year 2020, she purchased 0.80 acres of agricultural land in Sy. No. 336 for Rs. 1,61,00,000 and subsequently converted it into commercial land to establish the HPCL filling station, investing significant amounts in development. A lease agreement with HPCL was finalized in December 2021, and the filling station commenced operations in May 2022. Despite receiving prior assurances from the National Highways Authority of India (NHAI) that her land would not be impacted by the expressway project, a Gazette Notification issued by the NHAI in June 2022 listed her property for land acquisition, resulting in significant financial loss. The land acquisition is unjust and illegal, as assured by NHAI that her land would not be acquired. Hence, do the justice.

- 2. NHAI vide letter No. NHAI/AP/Tech/ST Commission/E-276776/2025/89 dated 25.3.2025 has furnished the facts and comments and stated that it is not possible to change the approved alignment and exemption of the land from acquisition as the proposed NH-544G crosses NH—42, an interchange with ramps and loops called double trumpet are proposed. Moreover, it is not feasible to shift the interchange in new alignment due to site constraints like Railway crossing, stream and nearby irrigation Tank.
- 3. In the sitting held on 09.04.2025, the Commission recommended the following and the minutes were sent to all concerned vide NCST letter dated 12.06.2025- "After discussion with the Chief General Manager (Technical), NHAI, Collector & DM, Sri Sathya Sai District (Telangana) and petitioner's husband, it was observed that no action is warranted on part of NCST. However, the petitioner is advised to file an appeal / application before the District Collector & Magistrate, Sri Sathya Sai District for compensation. The District Collector & Magistrate, Sri Sathya Sai District and NHAI are also advised to cooperate with the petitioner."
- 4. The Commission has decided to again discuss the issue with the authority and the petitioner on 11.08.2025. Accordingly, a Sitting Notice was sent on 02.08.2025. The petitioner Smt. Dungavath Chandrakala, M/s Nikhil Filling Station, located at Sy. No. 336, Malkavemula Village, Mudigubba Mandal, Sri Sathya Sai District, was represented by her husband Dr.Ramesh Naik and the authority was represented by the CGM, RO, NHAI, PD, NHAI, Kadapa on behalf of NHAI and RDO Puttaparthy on behalf of District Collector.
- 5. The petitioner has informed that NHAI has proposed land acquisition for the construction of the New Greenfield Expressway. In the year 2020, she purchased 0.80 acres of agricultural land in Sy. No. 336 for Rs. 1,61,00,000 and subsequently converted it into commercial land to establish the HPCL filling station, investing significant amounts in development. A lease agreement with HPCL was finalized in December 2021, and the filling station commenced operations in May 2022. Despite receiving prior assurances from the National Highways Authority of India (NHAI) that her land would not be impacted by the expressway project, a Gazette Notification issued by the NHAI in June 2022 listed her property for land acquisition, resulting in significant financial loss. Further informed that in the sitting held on 09.04.2025, the petitioner is advised to file an appeal / application before the District Collector & Magistrate, Sri Sathya Sai District and NHAI are also advised to cooperate with the petitioner." However the same has not progressed.
- 6. The authority ie, officials from NHAI have informed that it is not possible to change the approved alignment and exemption of the land from acquisition as the proposed NH-544G crosses NH—42, an interchange with ramps and loops called double trumpet are proposed. Moreover, it is not feasible to shift the interchange in new alignment due to site constraints like Railway crossing, stream and nearby irrigation Tank. It is further informed by the authorities that the arbitration is in progress and the valuation is yet to be finalized.

After hearing both the petitioner and authority the following recommendations are made and ATR may be submitted in 30 days from the receipt of the minutes-

a. It is observed that the petitioner has invested over Rs.3.00 Cr towards the HPCL filling station (ie, over Rs.1.60 Cr towards the purchase of land and over Rs.1.30 Cr for construction of structure)

b. The Department may duly examine the claim and compensate for the investment to a tune of Rs.1.40 Cr made on the structure.

c. The NHAI has sanctioned only 44 lakhs out of the investment made of Rs.1.60 Cr for the purchase of the land. The same is yet to be credited into the petitioners account. The District Collector, Sri Satyasai District and NHAI may immediately credit the same into the petitioners account and also examine the claim of enhancement of the compensation to bridge the gap w.r.t to the investment made.

 Further the District Collector may allocate the feasible alternate Government land for the petitioner to set up the petrol filling station.
