

## NATIONAL COMMISSION FOR SCHEDULED TRIBES

Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Shri Nakkala Chiranjeevi and others from Narikuravar Colony, Allimedu Village, Orakkadu Panchayat, Ponneri Taluk, Tiruvallur District (Tamil Nadu) regarding harassment to the Tribals Farmers by the Forest officials in cultivation of their land.

Shri Nakkala Chiranjeevi and others from Narikuravar Colony, Allimedu Village, Orakkadu Panchayat, Ponneri Taluk, Tiruvallur District (Tamil Nadu) vide their representation dated 26.07.2024, have alleged that lands measuring about 69 acres, originally allotted by the Government of Tamil Nadu to 56 members of the Nakkala Scheduled Tribe community under Survey Nos. 94/3H to 94/3M on 15.01.1971, were fraudulently sold without their consent by one Raghupathi, a former school teacher in their village. The petitioners claim that Raghupathi misrepresented the existence of a "tribal association," took original patta documents from them, and colluded with other villagers and government officials including the Deputy Tahsildar, R1, and V.A.O. Sharmila, to execute illegal registrations using fake documents. The petitioners further allege that eucalyptus crops planted on the land were also cut and taken by the fraudulent parties. They have enclosed supporting land records and requested the Commission's urgent intervention for restoration of the said land.

2. The Commission issued notice to the Chief Secretary, Govt. of Tamil Nadu and Collector and District Magistrate, Tiruvallur District on 09.08.2024 seeking facts and comments within 30 days. The reply was not received, hence, NCST has decided to discuss the issue with the authority and the petitioner on 05.08.2025. Accordingly, a Sitting Notice was sent on 28.07.2025. The District Collector, Tiruvallur District vide letter no. 896642/2023/B3 dated 31.7.2025 has furnished the facts and comments and also requested for exemption.

3. In the sitting, the petitioners were present and District Collector, Tiruvallur District was not present. Hence, the discussion was not held, as the Collector has furnished the detailed report. However the petitioners have informed that though thier names are present in the voters list of the said village and the land is under their posession, their land at the core was alienated from them in records and that they were being threatened by the Non-Tribals.

4. After discussion with the petitioner, it was observed that at present, no action is warranted on part of NCST. However, the reply of the District Collector, Tiruvallur District may be shared with the petitioner for information / satisfaction. The petitioners are advised to meet the District Collector, Tiruvallur in respect of their case. The District Collector/ Administration is also advised to cooperate with the petitioners for resolving the case and District Collector and District SP may attend the next scheduled date of hearing with the detailed report and status of grievance redressal.
