

Minutes of the sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi regarding rejection of candidature by Nuclear Fuel Complex, Department of Atomic Energy in the case of Shri S. Bansilal, Kothapalli, (M) Yacharam R.R.

Shri S. Bansilal, Kothapalli, (M) Yacharam R.R. District vide representation dated 03.04.2024 has alleged that he has applied for the post of Driver-cum-Operator (NFC) and got selected for the said post vide letter dated 04.10.2012. But the department has rejected his candidature. He had criminal cases against him which had already been settled before he applied for the job. He filed a case (WP18042/2013) in the Hon'ble High Court of Hyderabad for justice. The Hon'ble Court in its order dated 15.09.2023 directed the NFC to examine the case of the petitioner in the light of the decisions of the Hon'ble Apex Court in the cases of Avatar Singh and State of West Bengal and pass appropriate orders.

2. In this matter, a sitting was held on 17.10.2024 in which the following recommendation was made and the minutes was sent to all concerned on 29.11.2024 for submitting the action taken report,

• In view of decision of Hon'ble High Court of Telangana dated 15.09.2023, the offer of appointment may be issued to the petitioner at earliest.

3. The Nuclear Fuel Complex (NFC) vide letter no. NFC/PAR-I/22/11/2024/176 dated 22.01.2025 has informed that petitioner candidature was earlier cancelled due to suppression of criminal case details in the SSQ form. The matter was referred to the Department of Atomic Energy (DAE), whose Competent Authority observed that the petitioner had intentionally suppressed material facts despite clear warnings in the form and had been acquitted only on the basis of compromise, which does not amount to honourable acquittal. Further, the post of Driver-cum-Operator/A is no longer available, having been filled from the ST category waitlist. It was also stated that the High Court order dated 15.09.2023 did not hold NFC's action as wrong and a Speaking Order dated 30.03.2024 was already issued reiterating the same. The authority has denied any caste-based bias and has requested the Commission to treat the case as closed.

4. The petitioner again approached the NCST for justice. Therefore, NCST has decided to discuss the issue with the authority and the petitioner on 25.7.2025 which was postponed on the request of NFC and re-fixed on 08.08.2025. Accordingly, a sitting notice was issued on 29.7.2025.

5. The Secretary, DAE vide letter dated 7.8.2025 has requested for exemption and deputed Chief Executive, NFC, Director & Nodal Liaison Officer, DAE, Chief Administrative Officer, NFC and Liaison Officer, NFC.

6. In the sitting, the above officers of NFC and DAE were present. The petitioner was also present. The petitioner has reiterated his earlier submission and requested for justice. The Chief Executive, NFC reiterated the facts submitted by NFC dated 22.1.2025 and stated that the Department is not in position to issue offer of appointment to petitioner.

7. It was observed that, the facts submitted by NFC appears to be correct in respect of filling of said post by ST person but the petitioner remain unemployed and at this stage he could not apply for new job. Hence, it would be more appropriate the NFC may re-examine the case in consultation with the DAE, to provide justice with the petitioner.

8. After discussion with the above officers of NFC and DAE and petitioner, it was recommended that the NFC may re-examine the case in consultation with DAE and provide justice to the petitioner. The action taken /to be taken in the matter may be communicated to NCST at the earliest.
