

Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Shri T. Immanuvel Dinakaran, State Co-in charge, TN BJP, IT & Social Media, Chennai (Tamil Nadu) regarding implementation of Fundamental Facilities for Scheduled Tribes in the village of Vellore District.

**NCST/DEV-4821/TN/3/2025-RO-BHUV/RU-III**

**Date of the Sitting: 5/08/2025, 3:00 PM**

Shri T. Immanuvel Dinakaran, State Co-in-charge, Minority Information Technology & Social Media (TNBJP), Chennai vide his petition dated 09-08-2024 has submitted that the Scheduled Tribe residents of Peenjamandai Gram Panchayat comprising 43 hamlets in the Javadhu Hills region of Vellore District have been deprived of basic amenities such as hospital, school, electricity, drinking water, road, ambulance and ration facilities for the past 30 years. He highlights that residents travel 20 km for drinking water and that a drinking water lorry arrives only once a month. He alleges State Government negligence and urges intervention for implementation of basic facilities under the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006.

2. The Commission issued notice to the Secretary, Adi Dravidar and Tribal Welfare Department (AD&TW), Government of Tamil Nadu on 15.04.2025 seeking facts and comments within 15 days from receipt of the Notice. The Additional Secretary to Government, Adi Dravidar and Tribal Welfare Department, Tamil Nadu, vide letter dated 02-05-2025 has forwarded the matter to The Director, Tribal Welfare for furnishing the facts and comments an Action Taken Report to the Commission directly. A copy of this letter endorsed to NCST and petitioner. There was no reply from concerned department, hence, NCST has decided to discuss the issue with the authority and the petitioner on 05.08.2025. Accordingly, a Sitting Notice was sent on 28.07.2025.

3. The Secretary, AD&TW, Govt. of Tamil Nadu vide letter dated 4.8.2025 has directed the Director, Tribal Welfare Department, Chennai to attend the sitting at NCST, New Delhi.

4. In the sitting, the Joint Director (Scholarship) Directorate of Tribal Welfare and petitioner was also present. The petitioner has alleged that the AD & TW Department, Govt. of Chennai is not implementing welfare and development schemes for the STs properly. The officer of Tribal Welfare Department has provided the letter no. TD/C1/3252/2024 dated 4.8.2025 of Director, Tribal Welfare Department, Chennai addressed to Secretary, AD & TW, Govt. of Tamil Nadu. In the letter it has been mentioned that the Govt. is organizing the special camps for providing the facilities of Civil Supplies Cards, Old age pension Scheme and Adhar Card. In addition to this it has also informed that the connecting road has been constructed for the said village and details of titles given under FRA were provided. A Hostel for Girls has recently been constructed in the said village. A camp is also scheduled to be held on 11.8.2025 with focus to enroll under the Chief Minister Comprehensive Health Insurance Scheme (CMCHIS) for ensuring financial protection and health coverage for tribal families.

5. After discussion with the officer, TW and petitioner, the following recommendations were made and action taken thereon may be submitted within 30 days from receipt of the minutes.

- It is observed that the Drinking water projects are completed and some are ongoing and in progress. All the ongoing developmental works, as discussed in the sitting may be completed within 3 months.
- The outreach of health care is informed with regard to the availability of health infrastructure and screenings undertaken so far. However the Out-come of the camp scheduled on 11.8.2025 may also be communicated to NCST.
- The details of activities being undertaken in the said village may be shared with the petitioner, under intimation to NCST.
- Gramsabhas may be conducted to discuss the pending issues relating to the welfare and development and suitable necessary action may be taken.
- The Commission may schedule the visit to Javadi Hills, Vellore shortly to undersnad the field situation.
- As the petitioner is involved in volunteer activities relating to Health care outreach, necessary support may be provided to him to utilise his services within the existing institutional mechanisms.
