

Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Shri Munavath Narshima Naik, S/o Bhojya, R/o Ganesh Kunta Thanda(V), Rayaparthi Mandal of Warangal District, Telangana State regarding harassment in the matter of allotment of plots at Sangareddy District.

Shri Munavath Narshima Naik, R/o. Ganesh Kunta Thanda Village, Rayaparthi Mandal, Warangal District, vide his petition dated 17.06.2025 has stated that he, belonging to the ST Lambada Community and living below the poverty line, had purchased multiple plots situated at Pedda Kanjarla Kalan, Sanga Reddy District from the original owners of Sri Sai Ram Welfare Society. Despite producing valid registered documents (Doc. Nos. 6630/1984, 8564/1986, 2028/1985, 510/1984, and 40940/1985), the President of the Society and the District Registrar allegedly stopped the registrations and threatened him using caste-based abusive language, claiming the land would be given for development without informing the buyers. He has alleged that Revenue officials, in collusion with realtors and the Society's President, denied his right to the property and intimidated him with casteist remarks. He has sought the Commission's intervention to direct the District Collector and District Registrar, Sanga Reddy, to ensure proper demarcation and registration of his allotted plots and to take action against the officials involved.

2. NCST issued notice to the Collector and District Magistrate, District- Sangareddy on 02.07.2025 seeking facts and comments within 30 days from receipt of the Notice. The reply was not received, hence, NCST has decided to discuss the issue with the authority and the petitioner on 08.08.2025. Accordingly, a Sitting Notice was sent on 31.07.2025.

3. In the sitting, the District Revenue Officer (DRO), Sangareddy and petitioner were present. The petitioner has reiterated his earlier submission and requested for justice. The DRO, Sangareddy has provided the letter bearing no. C2/NCSC/70/2025 date 6.8.2025 of Collector & District Magistrate, Sangareddy. In the letter it has been mentioned that the matter was enquired by Police Department and Revenue Department of the District. The Police Department has informed about the name of the purchasers. These purchaser subsequently developed the land into plots and established Sri Sai Ram Welfare Housing Society, Hyderabad, selling the plots to various individuals and the Tahasildar's report concluded that the petitioner's name does not appear as a pattadar in any revenue record and the petitioner has not approached the Tahasildar's office for any clarification.

4. The RDO, Sangareddy has reported with regard to non registration of plots covered in Sy.No. 120, 121 & 125, situated at Peddakanjarla Village of Patancheru Mandal, Sangareddy District and related allegations, the matter involves multiple agencies and requires detailed verification of land records, registration documents and statements from concerned officials. Further, reported that the Tahsildar, Patancheru Mandal is involved in the Special drive on disposal Bhu Barathi applications which is flagship programme of Government of Telangana, and is going on war foot basis. Further, a detailed survey needs to be conducted for the entire land covered in Sy.No.120, 121 and 125 as a part of land is Government land. In this connection, the Revenue Divisional Officer, Sangareddy has requested to grant one (1) month time to conduct a detailed enquiry, appraise the facts thoroughly and submit a comprehensive report in this matter.

5. After discussion with DRO, Sangareddy and petitioner, the following recommendations were made and action taken thereon may be submitted to NCST within 30 days from receipt of the Minutes.

- a. A detailed report on the ownership of the said layout and the Government land encroached by the layout may be submitted to NCST.
- b. A detailed report on registrations happened on the said layout may be submitted to examine the petitioners claim.
- c. The Registrar, stamps and registrations may attend to the next scheduled date of hearing.
