Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Shri Jitbahan Kandeiburu, At/PO- Bandhabhoi, PS- Tikayatpalli, Dist.- Sundergarh, Odisha regarding tribes of Sundergarh affected by the DAM.

Shri Jitbahan Kandeiburu has alleged that due to executive of the Rukuda Dam Project they have been displaced and they are been force to live to the other places, where they have been deprived of the basic amenities and bare necessities of life.

- 2. In this matter, sittings were held on 19.02.2024 and 8.1.2025. In the last sitting held on 8.1.2025, the following recommendations were made and the minutes were issued on 29.1.2025 to all concerned for submission of action taken report within 30 days from receipt of the minutes.
  - As per discussion in the sitting, the petitioner has submitted a representation on 09.1.2025 (copy enclosed).
  - The District Administration to ensure the provision of land, compensation for the loss of land and other valuables along with the benefits outlined under the Rehabilitation & Resettlement Policy and the FRA Patta, as prescribed in various laws, rules and regulations.
  - The availability of basic amenities in the habitations and essential necessities to all displaced families may be ensured by District Administration.
- 3. The action taken report was not received, hence, NCST decided to discuss the issue on 25.7.2025. Accordingly, a sitting notice was sent to all concerned on 18.07.2025.
- 4. In the sitting, the petitioner was present and the Sub Collector, Panposh, District Sundargarh was not present(as he was present in the sitting scheduled for 23.7.2025 at NCST.) He has provided the information on 23.7.2025 in relation to the matter. In the information, a copy of letter no. 600/Judl date 6.2.2025 of Collector, Sundargarh was also enclosed. This letter contains the action taken by the Administration on the recommendations of the sitting held on 8.1.2025 at NCST.
- 5. As per information provided by the District Sub Collector, Panposh, it was decided that the information furnished by the District Administration, Sundargarh vide letter dated 6.2.2025 may be shared with the petitioner for information/ satisfaction. After received of the reply from the petitioner, the further course of action will be decided by the NCST.
