Minutes of the Hearing held under the Chairmanship of Dr Asha Lakra, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi, In the case of Mr Rajesh Kumar Gond, Flat No. 302, Narayanguda, Hyderabad, Telangana, regarding harassment at workplace and abetment to suicide.

A complaint dated 29.12.2022 was received from Shri Rajesh Kumar Gond. In the complaint, it was stated that his relative, Shri Bablu Gond, who worked as a Junior Hindi Translator at the National Metallurgical Laboratory, was subjected to mental harassment by the accused, Mr. Aditya Maina, Administrative Officer, National Metallurgical Laboratory. It was alleged that Shri Bablu Gond had reported the matter to higher authorities several times. He subsequently attempted to commit suicide and is currently admitted to Tata Main Hospital, Jamshedpur, Jharkhand. The petitioner is seeking appropriate action against the accused.

2. In this regard, the Commission issued a notice dated 18.01.2023, seeking a report from Shri Prabhat Kumar, Superintendent of Police, District East Singhbhum, Jharkhand.

3. The Senior Superintendent of Police was present during the hearing and submitted that the matter has been withdrawn by the petitioner; hence, no action is required by the police.


