Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Shri Jainivalasa Vasudeva Rao, Technical Assistant in the Engineering Department, ITDA, Seethampeta regarding non-disbursal of salary and regularization of service.

Date of the Sitting: 17/06/2025, 04:20 PM Participants in the Sitting: As per Annexure

The petitioner, Shri Jainivalasa Vasudeva Rao, Technical Assistant in the Engineering Department, ITDA, Seethampeta, vide his petition dated 14.09.2024, has stated that he has been working on an outsourcing basis for the past 15 years and has been performing his duties satisfactorily. However, he has not received his salary since November 2021, causing severe financial distress to his family, including elderly parents and children. He has requested the Commission to intervene and instruct the Government to sanction his pending salary and also regularize his services as a

- 2. NCST vide notice dated 21.01.2025 sought facts and comments from Director, Tribal Welfare Department, Gov of Andhra Pradesh and Project Officer, ITDA, Seethampeta, Andhra Pradesh within 30 days of receipt of notice.
- 3. In the sitting held on 27.03.2025, the Commission recommended "After discussion with the Executive Engineer, TW Seethampeta and petitioner, the following recommendations were made and action taken thereon may be submitted to NCST within 30 days from receipt of the minutes.
- The Commissioner. Panchayat Raj and Rural Development Department may immediately release the budget as proposed by the Executive Engineer, ITDA Seetampeta and the Secretary. Tribal Welfare Department may pursue the matter for immediate payment of the salaries/wages to the petitioner and others.
- Technical Assistants of MGNREGS working in ITDAs may be treated on par with the Technical Assistants of MGNREGS OF PR&RD Department as many of them are STs and they have no other source of livelihood.
- The Travel Allowance and Special Leave may be reimbursed/granted in favour of the petitioner, as per their entitlement of the petitioner by the Tribal Welfare Department, Seethampeta or the concerned department.
- The Secretary, PR&RD and Secretary, Tribal welfare, Andhra Pradesh may attend the next scheduled date of hearing with compliance."
 - 4. The Commission again decided to discuss the issue with the authorities and petitioner on 17.6.2025. Accordingly, a sitting notice was sent on 9.6.2025.
 - In the sitting, the Member Secretary, PR&RD Department, Govt of Andhra Pradesh was present on behalf of Principal Secretary, PR&RD Department, Govt of Andhra Pradesh. The Executive Engineer, ITDA was present on behalf of Project Officer, ITDA, Seethampeta, AP. The representative of the petitioner was also present.
 - The petitioner informed that the salaries were pending for the period of November 2021 to May 2025. The Authority informed that the Principal Secretary has already addressed a memo for the Commissioner PR&RD and the issue is under active perusasion.
 - After discussion with the officials of PR&RD Department, Govt of Andhra Pradesh and ITDA. Seethampeta and the
 petitioner, the following recommendations were made and action taken report may be submitted to NCST within 30 days of
- The pending salaries of Sri Jaminivalasa. Vasudevarao and others working as technical assistants on outsourcing basis for the period 43 months ie, from November 2021 to May 2025 may be released immediately.
- Sri Jaminivalasa. Vasudevarao and others working as Technical Assistants in Engineering Department of ITDA Seethampet on outsourcing basis may be appointed on contract basis following GO MS NO 12 finance (HR .-I-& policy) department
- The petitioner may be granted Travelling allowance and Special leave on 27/03/2025 and 17/06/2025 as per the entitlement for attending the hearing at NCST.
