Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Dilkusha Guest House, Hyderabad in the case of Shri Banavath Chinna Naik, R/o Bommarajupalli Village, Epuru Mandal, Guntur District, Andhra Pradesh(9182491701) regarding dispossession from land allotted to him under a patta after the construction of Nagarjuna Sagar

Shri Banavath Chinna Naik, R/o Bommarajupalli Village, Epuru Mandal, Guntur District, Andhra Pradesh, has represented regarding dispossession from land allotted to him under a patta after the construction of Nagarjuna Sagar Dam. The petitioner stated that their land was acquired for the Nagarjuna Sagar Project and they were subsequently allotted pattas under a rehabilitation scheme, and have been cultivating the said land for the past 23 years. However, revenue officials have now issued pattas to others in the same land without any enquiry or prior notice, leading to dispossession.

- In the sitting held on 08.05.2025, the Commission stated the following and minutes were sent to all concerned on 07.08.2025. After discussion with the District Collector, Palnadu and petitioner, the following recommendations were made and action taken there on may be submit to NCST within 30 days from receipt of the minutes.
 - a. The District Collector, Palnadu, RDO and MRO, Epuru concerned may take immediate necessary action to survey the available vacant land and issue pattas for the dispossessed occupants." However as the issue is not resolved the Commission decided to discuss the issue with the authority and the petitioner on 28.08.2025. Hence a sitting notice was sent on 13.08.2025.
- 3. The Petitioner Chinna Naik has attended the sitting. The authority District Collector, Palnadu has also
- 4. The petitioner reiterated his plea. It is informed that they have been cultivating the land given under rehabilitation package for the last 22 years from 1991-2011 and after the Court orders, out of 48 PDFs only 31 were given the land and the remaining were left out. The House pattas were also assured but out of the total extent of 5 acres assured it is now confined to 3 acres and 2 acres is taken back. Further it is alleged that among 31 members, 7 are not the original PDFs and only 24 are genuine.
- The authority has informed that after the ceiling of the surplus land, PDFs were formed into Joint society and 348 acres of land is allocated to them. However as the High court order is issued in favour of the original owners, 31 eligible members were allocated at another place and others are given the DKT
- After hearing the petitioner and authority the following recommendations are made and ATR may be submitted in 15 days from the receipt of the Minutes
 - a. The list may be checked by the Revenue authorities and it may be ascertained as to who is staying in the allocated land.
 - b. The total land for Houses may be provided as assured.
 - c. The authorities may propose for the assignment of available Government land in case if any of the eligible ST BPL Families are missed out.
