

Minutes of the Sitting held under the Chairmanship of Dr Asha Lakra, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhiin the case of Mental & physical torture by Principal Chief Commercial Manager, South Eastern Railway (SER)-letter dated 15th May, 2025 of Shri Ajeet Kumar Tirkey, Dy Chief Commercial Manager/Claims & Refunds, residence of Village-Sirom Toli, Chutia, Ranchi (Jharkhand).

Date and Time of Sitting: 05.08.2025 at 03:20 PM Participants in the Sitting - As per Annexure

Shri Ajeet Kumar Tirkey, Deputy Chief Commercial Manager (Claims & Refunds), resident of Village-Sirom Toli, Chutia, Ranchi, Jharkhand, vide his letter dated 15.05.2025, has submitted a complaint alleging mental and physical harassment by Shri Upinder Singh, Principal Chief Commercial Manager (PCCM), South Eastern Railway (SER).

2. In his representation, Shri Tirkey has stated that he was transferred from South Eastern Railway, Kolkata to Metro Railway, Kolkata under circumstances perceived by him as punitive. He further alleged that on 06.05.2025, the PCCM humiliated, disgraced, and threatened him. He claims to possess supporting evidence of the incident in the form of a mobile phone recording. He has further stated that, being a member of the Scheduled Tribe (ST) category, the treatment and behaviour meted out to him by the PCCM has caused grave concern and may adversely affect his Annual Performance



Appraisal Report (APAR). He has also submitted that the humiliation and hostile work environment have led to depression and aggravated his existing psychological and medical conditions.

- In connection with this matter, a letter dated 16.06.2025 was issued to the General Manager, South Eastern Railway, Kolkata, seeking a factual report along with details of action taken. However, no satisfactory response has been received from the concerned authorities till date.
- In view of the seriousness of the matter, a sitting was scheduled on 05.08.2025. Accordingly, a notice for sitting was issued to the General Manager, South Eastern Railway, with a copy thereof forwarded to the petitioner for information.
- 5. However, the General Manager, South Eastern Railway, did not appear before the Commission on the scheduled date. Instead, the Principal Chief Commercial Manager (PCCM), South Eastern Railway Headquarters, appeared on his behalf.
- During the hearing, the Commission observed that since the allegations pertain directly to the Principal Chief Commercial Manager (PCCM), South Eastern Railway, and the said officer himself appeared to represent the General Manager, the arrangement was found to be inappropriate and inconsistent with the settled principles of natural justice (Nemo judex in causa sua). Consequently, the proceedings could not be conducted.

The Commission hereby directs that, in the next sitting-whenever scheduled-the General Manager, South Eastern Railway, is required to remain personally present before the Commission to enable completion of the proceedings.
