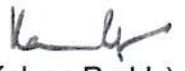

Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Dilkusha Guest House, Hyderabad in the case of Shri S. Nungiah regarding non allotment of FRA pattas.

Shri S. Nungiah, an ST Koya of Kannaigudem Gram Panchayat in Aswaraopeta Mandal, vide letter dated 22.05.2025 has represented that due to Forest Revenue disputes, around 35,000 acres of land across the villages of Kannaigudem, Aswaraopeta, Vedanthapuram, Duradapadu, Kavadigundla, Ramannagudem, and Asupaka in Aswaraopeta Mandal of Bhadradi Kothagudem District, Telangana, have still not been allotted FRA pattas, even though these lands have been under cultivation for a long time. Due to this, poor ST farmers are not receiving their entitlements and government support.

2. The Commission issued notice to the District Collector Bhadradi Kothagudem, District Forest Officer Bhadradi Kothagudem District and the Chief Commissioner of Land Authority, Hyderabad, Telangana vide NCST letter dated 14.08.2025 seeking facts and comments within 30 days.

3. Reply was not received hence the Commission has decided to discuss the issue with the authority and the petitioner on 19.09.2025. Accordingly, a Sitting Notice was sent on 12.09.2025.

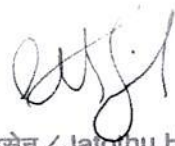
4. The Project officer, ITDA Bhadrachalam has attended the hearing on behalf of the District Collector. The petitioner has attended the hearing.

5. The petitioner has informed that the issue was long pending and was represented during the Hon'ble Members visit to Kavadigundla and around 35345 acres of land across the villages of kannaigudem (Sy.No.152), Aswaraopeta (Sy.No.911), Vedantapuram (Sy.No.122), Duradapadu(Sy.No 54), Kavadigundala(Sy.No.24), Ramannagudem(Sy.No 30,36,39) and Asupaka(Sy.No 40, 41) in Aswaraopeta mandal of Bhadradi Kothagudem District were not issued pattas due to Forest Revenue Boundary dispute, due to which the ST farmers are losing the farm input assistance under the scheme of Rythubandhu/Rythubarosa. The non tribals are issued pattas whereas the tribals are denied pattas.

6. The authority has informed that given the vast extent of land and complex overlapping problems claims and due to the scarcity of the licensed surveyors the survey got delayed and now as the new surveyors have come the survey will be taken up shortly.

7. After hearing to both the petitioner and authority the following recommendations are made. The ATR may be submitted in 30 days from the receipt of the minutes.

- a. The joint survey by Forests and Revenue Departments may be completed in 30 days.
- b. The villagers are advised to cooperate with the officials for the conclusion of the joint survey.
- c. Patta pass books may be issued to all the eligible ST Framers.
