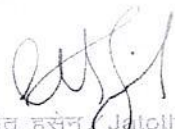
NATIONAL COMMISSION FOR SCHEDULED TRIBES

Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Dilkusha Guest House, Hyderabad in the case of Shri G. Hamsa Reddy, B.E., Rtd. Supdt. Engineer regarding forceful occupation of his land.

Shri G. Hamsa Reddy, B.E., Rtd. Supdt. Engineer, vide his petition dated 09-08-2021, has stated that patta lands measuring Ac.3,284-00 Gts originally allotted by the Nizam Government between 1905-1909 to his grandfather late Sri Guguloth Kishtu Naik in Veernapally and Maddimalla villages of present-day Rajanna Siricilla district, Telangana, have been forcibly occupied by trespassers and transferred in their names through manipulation of revenue records. Despite multiple representations from 1994 onwards, including specific pleas in 2020 and 2021, the Revenue Department has failed to act or issue new pattadar passbooks to the affected ST families, except for 9 passbooks issued in 1999 for Ac.140-00 Gts. Although the current extent of land is only Ac.341-18 Gts, no fresh passbooks have been issued since 1999, and the petitioner alleges that records have been tampered with without notice. Supporting documents such as sanction orders, chow fasla pahanies, khasra pahani, revenue tax receipts, and passbooks have been provided. He seeks the Commission's intervention for a detailed enquiry and restoration of dispossessed lands to the ST families.

2. The Commission issued notice to the Collector & District Magistrate, Suryapet vide NCST letter dated 13.07.2022 seeking facts and comments within 15 days.
3. In the sitting held on 20.10.2022, the Commission recommended that "The District Collector may constitute a team of Officials to make a discreet enquiry of the entire issues raised by the Petitioner and submit detailed report before the Commission within a period of 30 days".
4. District Collector, Rajanna Siricilla, vide letter dated 22.12.2022, has informed the Commission that pursuant to its directions dated 20.10.2022, a memo was issued to Sri G. Hamsa Reddy to attend the Collector's office on 03.12.2022 and submit relevant documentary evidence regarding his claims of land dispossession and manipulation of revenue records. While Shri Reddy appeared on the said date, he did not submit any fresh or additional documents. A copy of Memo No. B/4097/2001 dated 01.02.2011, originally issued by the Tahsildar, Yellareddipet to writ petitioners in W.P. No. 17082/2008, was furnished to him for reference, though he was not a party to that writ. It was further explained to him that the civil suit O.S. No. 43 of 2004 was dismissed for default on 25.11.2015 and no orders were passed by the Junior Civil Judge, Siricilla; hence, no further action could be taken. The Collector has requested the Commission to consider the above facts and close the matter.
5. Thereafter there were several correspondences but the issue could not be resolved. Hence the Commission decided to discuss the issue with the authority and the petitioner on 19.09.2025. Accordingly, a Sitting Notice was sent on 12.09.2025.
6. The petitioner has attended for the hearing. The Additional Collector, Revenue has attended on behalf of the authority ie, District Collector, Rajanna Siricilla.

7. The petitioner informed that he has evidences of his claim and has quoted Koneru Rangarao committee recommendations regarding the land holdings prior to 1950.

8. The authority has informed that if the petitioner or his predecessors were in possession of the claimed extent of Ac.341.18 Gts, they should have filed declarations as required under AP Land Reforms Act, 1973. But they have not filed any declarations in respect of the extent claimed by the petitioner. As per the report of the RDO, Siricilla and Tahsildar, veeranpally the records were verified and it is found that neither the petitioner nor his family members are in possession of any land out of Ac.341.48 Gts claimed by the petitioner in Veeranpalli and Maddimala villages.

9. After hearing to both the petitioner and authority the following observations are made.

- a. It is known from the report that the petitioner has not produced any evidence with respect to his relation with the said grantee Sri Guguloth Kistu Naik. Neither has he not appeared before the Revenue Court with appropriate documents to substantiate his claim earlier.
- b. Further, the commission observed that petitioner claim is irrational as he is claiming the land after the lapse of several decades as many have already been in possession with registered sale deed documents. Many transfers and mutations may have occurred and It is not justifiable to alienate the land from them. Hence no action is warranted on part of NCST.

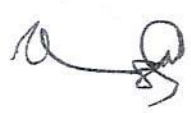
