## NATIONAL COMMISSION FOR SCHEDULED TRIBES

Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Dilkhusha Guest House, Hyderabad in the case of Smt. Bhukya Vandana, W/o Ganesh (Police Constable), Brindavan Colony, Hanam Konda, Telangana regarding death of petitioner's son due to negligence of SR Prime College, Battupally.

Smt. Bhukya Vandana, W/o Ganesh (Police Constable), Brindavan Colony, HanumaKonda, Telangana, vide her petition dated 26.06.2025, has stated that her son Bhukya Purna Charan Teja, a student of SR Prime College, Battupally, developed severe food poisoning after consuming dinner at the hostel on 05.08.2024. Despite being hospitalized, the college discharged him without consent, after which his condition worsened, leading to multiple organ failure. He was treated at KIMS Hospitals but, due to lack of financial support from the college management, a recommended lung transplant could not be undertaken, and he passed away on 29.08.2024. The petitioner alleged that despite complaints to the Food Inspector, Police, and ACP Davender Reddy, no effective action was taken, and the college offered only ₹4 lakhs against nearly ₹20 lakhs spent on treatment. She has requested the intervention of the Commission for justice and adequate support, alleging negligence and lack of accountability on the part of the college management and inaction by the police authorities.

- 2. NCST vide notice dated 31.07.2025 sought facts and comments from the Commissioner of Police, Hanumakonda, Warangal within 15 days.
- 3. No reply has been received hence the Commission decided to discuss the issue with the authority and the petitioner on 26.09.2025. Accordingly, a Sitting Notice was sent on 15.09.2025.
- 4. The petitioner has attended the hearing. The ACP, Hanumakonda has attended on behalf of the authority.
- 5. The petitioner has reiterated the plea and informed that the management has been irresponsible in attending to the health condition of the student and has admitted and discharged from the hospital without informing the parents. Further the Food inspector has not attended to the inspection on time giving scope for the escape of the management. Further they did not financially support the treatment of the student leading to the loss of life.
- 6. The authority has informed that the (2) students who have passed away may have suffered from the depression due to homesickness and have attempted suicide as they found the residues of herbicides in the viscera as per the postmortem report. It is informed that there is no scope of food poisoning as none of the other students have suffered from the illness.
- 7. After hearing to both the petitioner and authority the following recommendations were made and ATR may be submitted in 30 days from the receipt of the minutes.
  - a. The Director/Commissioner, Board of intermediate Education may cause an enquiry on the history of such instances of deaths in the corporate intermediate colleges in Telangana especially the SR Group of colleges as it is reported that such instances have also occurred in the past.
  - b. The CP, Warangal may submit a detailed report on the involvement of Police staff, ACP and CI in mediating the case and threatening the petitioners.
  - c. The Director/Commissioner, BIE may ensure that the corporate college makes necessary compensation to the bereaved family.
  - d. The Food inspectors may periodically visit the kitchens/Dining halls/store rooms of the colleges and test the samples so as to ensure that such incidences do not repeat in future.
