NATIONAL COMMISSION FOR SCHEDULED TRIBES

Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Dilkhusha Guest House, Hyderabad in the case of Shri B. Laxman, R/o Hyderabad regarding harassment and caste abuse.

Shri B. Laxman, R/o Hyderabad, vide his complaint has alleged that on 12.09.2023, Shri Pradeep Machineni, Shri K. Srinivas and their associates, with the support of anti-social elements and local police, criminally trespassed into his land measuring Acs. 7-00 Gts. in Sy.No.17, Guttala Begumpet, Ranga Reddy District, assaulted his watchman, damaged property, humiliated him with caste-based abuses, and threatened to kill him and his family unless he signed blank papers. He further alleged that the police not only refused to register his complaint but also filed a false case (Crime No.1012/2023) against him under IPC sections at the instance of the accused. He stated that he was illegally confined at Madhapur Police Station, coerced by the then Inspector Naredla Thirupathi and DCP Sandeep Rao to sign blank papers, and threatened with dire consequences. He also alleged cheating through a fraudulent MoA dated 18.05.2022 with M/s Tesla Projects Pvt. Ltd., where the agreed terms were altered, and forged documents were created to claim his land worth over ₹70 crores. He has sought action against the accused persons, including the said police officials, under SC/ST (Prevention of Atrocities) Act and requested protection for his life and property.

2. NCST vide notice dated 08.07.2024 sought facts and comments from Director General Of Police, Telangana and Collector & District Magistrate, District-Ranga Reddy within 30 days.

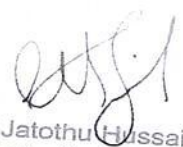
3. Reply was not received hence the Commission decided to discuss the issue with the authority and the petitioner on 26.09.2025. Accordingly, a Sitting Notice was sent on 15.09.2025.

4. The petitioner has attended the hearing. The Deputy Collector, Ranga Reddy has attended on behalf of the District Collector and the ACP, Madhapur has attended on behalf of DGP.

5. The petitioner has sought action against the accused persons, including the said police officials, under SC/ST (Prevention of Atrocities) Act and requested protection for his life and property.

6. The District Collector in his report has informed that as per the Bhu Bharathi Pahani, the name of the complainant Sri. Banoth Laxman is recorded as pattadar of the subject land to an extent of Ac.7.00 Gts in survey No.17 of Guttalabegumpet village, Serilingampally Mandal. The subject land is being claimed by three parties ie, 1.B.Laxman (the complainant) who is stated to have been purchased from the pattadar V. Venkateshwar Rao, through unregistered sale deed subsequently validated before District Registrar 2. K.Sudha & her legal heirs who are stated to have been granted decree vide OS No.12/82 and 3. K.srinivasa Rao who is stated to be a GPA Holder of original pattadar Sri. V.Venkateshwar Rao. The subject land is covered by interim directions of the Hon'ble High Court passed in Writ petition No.3922 of 2023 on 24.3.23.

7. The ACP, Madhapur Division, Cyberabad has mentioned in his report that Mr. Pradeep Machineni and Mr.K.Srinivas created a forged General power of attorney in favour of Mr. K. Srinivas by forging the signature of his original vendor Sri Vemula Venkateshwar Rao. Using this fake document, they filed WP No.4518 of 2023 falsely claiming rights over his land and making him as a respondent. Upon knowing that the police registered a false criminal case against him based on a complaint by K.Srinivas under Crime No.1012/2023 Dated 12.9.23 for alleged offences under sections 406, 419, 420, 468, 471 r/w 34 IPC the petitioner requested for necessary actions against Mr. Pradeep Machineni, Mr K Srinivas and, Mr. K.Narayana Reddy, Ahmed and Asif. On receipt of the petition, a case in Cr.No.1818/2025 U/s 447, 427, 406, 420, 467, 468, 471, 342, 504, 506 IPC & Section 3 (1)(s)(r) of SC/ST POA-2015 and taken up the investigation. Presently the case is under investigation.

8. After hearing to the petitioner and authorities, the following recommendations are made by NCST.

- a. The investigation may be concluded at the earliest possible time and the responsible miscreants punished under the provisions of SC ST Prevention of Atrocities Act.
- b. Necessary protection may be given to the petitioner by the Police Department as he has under continuous threat.
- c. The Revenue Department may keep a watch on the forged documents in the land disputes.
