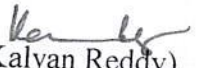

NATIONAL COMMISSION FOR SCHEDULED TRIBES

Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Dilkusha Guest House, Hyderabad regarding slow progress of works in NH 930 on the Gourelli-Hyderabad-Kothagudem route, where due to poor design and culvert arrangements, drainage is causing serious inconvenience to the neighboring ST habitations.

NCST took suo moto cognizance of a news item published in various dailies regarding the slow progress of works in NH 930 on the Gourelli-Hyderabad-Kothagudem route, where due to poor design and culvert arrangements, drainage is causing serious inconvenience to the neighboring ST habitations. The report highlights that highway construction works at Tirumalagiri crossroads in Nalgonda are progressing very slowly, causing severe difficulties to the public. Locals allege that drainage works on either side of the highway are being carried out without removing the existing slabs, violating government norms, resulting in incomplete drains that allow sewage water to flow onto the roads. This has led to foul smell, mosquito breeding, and risk of infectious diseases, troubling shop owners and residents. The highway and flyover works, pending for over a year, have left roads dusty in summer and muddy in rains, affecting health and business as shopkeepers struggle to pay rents due to reduced income. People accuse contractors of acting arbitrarily and demands that authorities intervene, complete drainage, flyover, and bridge works quickly, and ensure that construction adheres to proper standards.

2. NCST vide notice dated 08.09.2025 sought facts and comments from the Principal Secretary, Roads And Buildings Department, Government of Telangana and Regional Officer, National Highway Authority of India within 05 days.

3. Reply was not received hence the Commission decided to discuss the issue with the authority on 26.09.2025. Accordingly, a Sitting Notice was sent on 15.09.2025.

4. The ENC, R&B, SE, NH, Warangal have attended from the Roads and Buildings Department, Government of Telangana and RO, MoRTH and RO, NHAI have attended from the MoRTH and NHAI respectively. The petitioner has also attended the hearing.

5. The authority has stated that the stretch from Gourelly to Kothagudem as NH 930 P was approved vide Gol Gazette No. S.O 1494(E) Dated 7.4.21. The NH Starts from the Junction with Hyderabad ORR near Gowrelly and traverses through Valigonda, Thorur, Nellikuduru, Mahabubabad, Yellandu and terminates at its junction with NH-30 near Kothagudem in the State of Telangana. The proposed work of Rehabilitation and Upgradation of Valigonda to Thorur Section to Two lane with paved shoulders from Km 39/180 to Km 108/300 of NH 930 P is approved by MoRTH vide Gol letter No 441 Dated 28.7.22.

6. Further it informed that the culvert/minor Bridge mentioned is located at Km 90+846 of Gowrelly-Valigonda-Thorur Section of NH-930 P. There was an old minor bridge existing since more than 50 years which is having a width of 7.50 m and constructed with stone masonry. As this old bridge will not cater to the traffic as per IRC standards, the reconstruction of existing minor bridge is proposed based on discharge calculations and catchment area. The Bridge work is executed by the EPC Contractor under the supervision of Authority's Engineer/Authority (EE NH Jangaon).

7. The petitioner has informed that during heavy rainfall the flood passes through the bridge with high velocity and enters the premises of nearby houses and further due to the inundation, the mosquito menace is leading to the communicable diseases like Malaria, Dengue etc and due to the faulty design and repair works many accidents are taking place.

8. After hearing to both the petitioner and authority, the following observations/ recommendations are made.

- a. Proper signboards and speed breakers may be kept as Work in progress to avoid accidents.
- b. The Local people are in favour on a bypass road without hindering the established E-NAM Agricultural market. Hence the proposal may be examined.
- c. Further requirement of culverts on the said route may be examined to avoid submergence and logging of the water near the Houses.
- d. The illegal mining of the soil across bunds of the SRSP canals may be avoided to address soil erosion.
- e. The Commission may schedule a visit shortly to evaluate the field situation of any inconvenience to the local ST Habitations/Scheduled Tribes community.
