NATIONAL COMMISSION FOR SCHEDULED TRIBES

Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Shri Nakkala Chiranjeevi and others from Narikuravar Colony, Allimedu Village, Orakkadu Panchayat, Ponneri Taluk, Tiruvallur District (Tamil Nadu) regarding harassment to the Tribals Farmers by the Forest officials in cultivation of their land.

Shri Nakkala Chiranjeevi and others from Narikuravar Colony, Allimedu Village, Orakkadu Panchayat, Ponneri Taluk, Tiruvallur District (Tamil Nadu) vide their representation dated 26.07.2024, have alleged that lands measuring about 69 acres, originally allotted by the Government of Tamil Nadu to 56 members of the Nakkala Scheduled Tribe community under Survey Nos. 94/3H to 94/3M on 15.01.1971, were fraudulently sold without their consent by one Raghupathi, a former school teacher in their village. The petitioners claim that Raghupathi misrepresented the existence of a "tribal association," took original patta documents from them, and colluded with other villagers and government officials including the Deputy Tahsildar, R1, and V.A.O. Sharmila, to execute illegal registrations using fake documents. The petitioners further allege that eucalyptus crops planted on the land were also cut and taken by the fraudulent parties. They have enclosed supporting land records and requested the Commission's urgent intervention for restoration of the said land.

- 2. In this matter, sitting was convened on 5.8.2025 and following recommendations were made and minutes forwarded to all concerned on 3.9.2025.
- The reply of the District Collector, Tiruvallur District may be shared with the petitioner for information / satisfaction. The petitioners are advised to meet the District Collector, Tiruvallur in respect of their case. The District Collector/ Administration is also advised to cooperate with the petitioners for resolving the case and District Collector and District SP may attend the next scheduled date of hearing with the detailed report and status of grievance redressal.".
- 3. The action taken report was not received from concerned authorities, hence, NCST has decided to discuss the issue with the concerned authority and petitioner on 16.10.2025. Accordingly, a sitting notice was sent to the concerned authority and petitioner on 6.10.2025.
- 4. The District Collector, Tiruvallur District vide letter no. 896642/2023/B3 dated 13.10.2025 has furnished the facts and comments and requested for exemption. In the letter, it has been mentioned that in respect to other survey Nos.94/3C, 94/3F, 94/3H, 94/3J, 94/3K and 94/3M, the enquiry is under process for collecting some vital documents for ascertaining the land ownership. Therefore, it is requested to dispense his personal appearance on 16.10.2025, since, the representation made by the petitioners is partly complied with and the remaining claims of the petitioners is under process for reporting compliance.
- 5. In the sitting, District- Adi Dravidar and Tribal Welfare Officer, Thiruvallur and petitioner were present. The petitioner has reiterated his earlier submission and requested for justice. The officer from the District Administration has provided the copy of letter no. 896642/2023/B3 dated 13.10.2025 of District Collector, Tiruvallur District, which contains the facts in the said matter.
- 6. After discussion with the above officer of District Administration and petitioner, the following recommendations were made and action taken there on may be submitted to NCST within 30. days from receipt of the minutes.
- The District Collector is advised to expedite the process, as mentioned in the letter dated 13.10.2025 within a
 month and submit the report to NCST.
- It the report not received in time, the NCST will convene a sitting for discussion with the District Collector and District SP, Tiruvallur (in person) for redressal of the grievance of the petitioners.
