Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Mrs. M. Prashanthi, Director, Sri Ramshanthi Industries Pvt. Ltd. Venkateswara Colony, Jadcherla, Mahabubnagar (Telangana) regarding delay in allotment of plot approval in GIP\_Jadcherla.

Smt. M. Prashanthi, Director, M/s Sri Ramshanthi Industries Pvt. Ltd., vide her representation dated 10.09.2025 has stated that she had applied for plot No.57 (ID No.62431) in GIP, Jadcherla, and attended a meeting on 11.07.2025, wherein the Joint Chief Environmental Engineer, TGPCB Zonal Office, Begumpet, Hyderabad, clarified that TGIIC would approve the provisional allotment before issuing the Consent for Establishment (CFE) as per NGT directions. She stated that her project, selected under Startup Mahakumb 2025, funded by IFCI VCF Ltd. (Ministry of Tribal Affairs), must utilize the funds before 30.09.2025, failing which they would lapse. Despite reminders to the Vice-Chairman & Managing Director, TGIIC, the approval has been pending for three months. She has requested the intervention of NCST for early approval of the plot allotment.

2. NCST vide notice dated 15.09.2025 sought facts and comments from the Vice Chairman & Managing Director, Telangana State Industrial Infrastructure Corporation Limited within 7 days from receipt of the Notice. The reply was not received, hence the Commission decided to discuss the issue with the authority and the petitioner on 16.10.2025. Accordingly, a Sitting Notice was sent on 06.10.2025.

3. In the sitting, officers from TGIIC, Hyderabad and petitioner's representative were present. The petitioner's representative has reiterated their submission and requested for justice. The officers from TGIIC, Hyderabad given the statement which contains the facts and comments and action taken by the TGIIC in the matter. In the statement, it has been informed that TGIIC pursuing the orders of NGT and Environmental Clearance. TGIIC assures that the application of petitioner will be processed upon further order from Hon'ble NGT.

4. After discussion with the above officers of TGIIC and petitioner, the following recommendations were made and action taken there on may be submitted to NCST within 15 days from receipt of the minutes.

- a. The petitioner may explore the feasibility of alternate locations proposed by the Industries Department.
- b. The TGIIC may immediately take action after the hearing of the National Green Tribunal and the Ministry may be addressed for feasible relaxation of the due date.
- c. The VC&MD, TGIIC may attend to the next scheduled date of hearing.
