

NATIONAL COMMISSION FOR SCHEDULED TRIBES

Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Dilkusha Guest House, Hyderabad in the case of Smt. K. Vani, Deputy Commissioner & Executive Officer regarding revision of seniority and notional promotion.

Smt. K. Vani, Deputy Commissioner & Executive Officer, Sri Nekkanti Anjaneya Swamy Vari Devasthanam, Kasapuram, Anantapuramu District, vide her representation dated 15.07.2025, has stated that she belongs to the Scheduled Tribe (ST) category and was promoted and posted as Deputy Executive Officer & Deputy Commissioner at Sri Varasiddi Vinayaka Swamy Vari Devasthanam, Kanipakam, Chittoor District vide proceedings RC.No.E1/5396918/2022-17, dated 07.02.2024, and subsequently transferred to her present posting on 24.09.2024. She submitted that out of 29 sanctioned posts of Deputy Commissioners, only one post is filled under the ST category. Referring to Office Memorandum No.36012/5/97-Estt.(Res.) Vol.II, dated 20.07.2000, and G.O.Ms No.21 dated 18.03.2003 and G.O.Ms No.2 dated 09.01.2004, she contends that her case falls under roster point 58 (ST-Women) and therefore seeks revision of seniority and notional promotion with all consequential monetary benefits in accordance with the said government orders and reservation policy.

2. NCST vide notice dated 22.07.2025 sought facts and comments from The Commissioner, Endowments Department, Government of Andhra Pradesh within 30 days.
3. No reply has been received hence the Commission decided to discuss the issue with the authority and the petitioner on 06.12.2025. Accordingly, a Sitting Notice was sent on 28.10.2025.
4. The petitioner has attended the hearing. The Commissioner, Endowments, Govt of AP has attended the hearing.
5. The petitioner reiterated her plea and has requested for the review of the roster and revision of seniority and notional promotion with all consequential monetary benefits in accordance with the government orders and reservation policy.
6. The authority has informed that Smt. K.Vani, Assistant Commissioner was considered for promotion as Deputy Commissioner as per her seniority and was not considered at Roster point(ST)(58) as adequacy was reached by then and the said roster point was filled as per the seniority strictly adhering to the GO Issued for implementation of RoR. It is further mentioned that Smt. Radha Singam (ST Roster Point No.33) incumbent against the Roster point No.58 and Smt. K.Vani were promoted on the same date ie, 7.2.2024 and as such even if it is assumed that she is considered against the roster point no. 58, there will be no change in her date of promotion to the cadre of Deputy Commissioner.
7. After hearing to the petitioner and authority the following recommendations are made and the Action Taken Report may be submitted in 30 days from the receipt of Minutes.
 - a. The review may be made as assured by the authority as the petitioner claims that there would be advantage for her in scale if the same is made.
 - b. The petitioner may approach the Hon'ble NCST at any time, if found lapses in fixation of seniority after review.
 - c. The travelling allowance and special leave may be reimbursed or granted in favour of in petitioner as per the entitlement by Endowment Department, Government of Andhra Pradesh, Vijayawada for attending the sitting sessions on 16-10-2025 and 06-11-2025.


