Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Dilkusha Guest House, Hyderabad in the case of Shri P. Krishna Reddy, Executive Officer Gr-III regarding denial of promotion.

Shri P. Krishna Reddy, Executive Officer Gr-III, Group Temples, Timmapuram, Kakinada Rural, Andhra Pradesh, vide his representation dated 21.03.2025 has requested promotion to the cadre of Executive Officer Gr-II under A.P.C.H.R.I. & Endowments Subordinate (Non-Gazetted) Service Rules, 2002 on ROR (ST) quota. He stated that he belongs to the ST community, was initially appointed as Junior Assistant under SC/ST backlog vacancies, and has been serving as Executive Officer Gr-III since 27.06.2019, completing 14½ years of service in the department. He has passed all departmental tests, and the Kakinada Zone-II has six posts earmarked for ST candidates, indicating availability of vacancies. Despite submitting multiple representations to the Deputy Commissioner, Endowments, Kakinada and the Commissioner of Endowments, Vijayawada, no action has been taken. He requested the Commission to examine his case for promotion under the ST quota.

2. NCST vide notice dated 02.07.2025 sought facts and comments from The Commissioner, Endowments Department, Government of Andhra Pradesh within 30 days.
3. No reply has been received hence the Commission decided to discuss the issue with the authority and the petitioner on 06.11.2025. Accordingly, a Sitting Notice was sent on 28.10.2025.
4. The petitioner has attended the hearing. The Commissioner, Endowments Department, Government of AP has attended the hearing.
5. The authority has informed that the seniority list of the Executive Officer Grade III in Kakinada Zone has been finalized vide Office Rc.No.E2/15022/51/2024 Dated 22.9.2025. Accordingly the vacancies of Executive Officer, Grade II which are earmarked to the Executive officers Grade III, the Departmental senior assistants and temple senior assistants working in Endowments Institutions in Kakinada Zone are filled with eligible persons of the earmarked categories as per the prescribed cycle. Hence the grievance is addressed.
6. The petitioner confirmed that his grievance is resolved.
7. After hearing to the petitioner and authority the following observations/recommendations are made.
  - a. It is observed that no further action is warranted on part of NCST as the petitioner has confirmed that his grievance is addressed.
  - b. The travelling allowance and special leave may be reimbursed or granted in favour of in petitioner as per the entitlement by Endowment Department, Government of Andhra Pradesh, Vijayawada for attending the sitting sessions 16-10-2025 and 06-11-2025.
