

NATIONAL COMMISSION FOR SCHEDULED TRIBES

Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Dilkusha Guest House, Hyderabad in the case of Shri N. Hanumanth, S/o N. Dasu, R/o Jammula Thanda, Savaigudem Village, Wanaparthy (Mandal & District) and others regarding lack of basic amenities.

Shri N. Hanumanth, S/o N. Dasu, R/o Jammula Thanda, Savaigudem Village, Wanaparthy (Mandal & District) and others, vide their representation dated 06 June 2025, has informed the Commission that they are facing discrimination and denial of basic amenities, particularly the lack of road connectivity to their Thanda. They have repeatedly requested the government for an 800-meter road through government and privately owned lands, but their requests were denied by local landowners and political influences, and police complaints have not been registered against the offenders. They also approached the District Collector, Wanaparthy in January 2025, but were met with dismissive and insulting remarks. They have requested the Commission's intervention to ensure provision of basic amenities to their Thanda.


2. The Commission issued notice to the District Collector & Magistrate, District-Wanaparthy vide NCST letter dated 03.10.2025 seeking facts and comments within 15 days.

3. Reply has not been received hence the Commission has decided to discuss the issue with the authority and the petitioner on 06.11.2025. Accordingly, a Sitting Notice was sent on 28.10.2025.

4. The petitioner has attended to the eharing. The Additional Collector, Wanaparthy has attended on behalf of the District Collector, Wanaparthy.

5. The petitioner has reiterated his plea. The petitioner has stated that the RDO, Wanaparthy has processed a proposal for allocation of 0.0750 Gts of land for the Thanda Road. A paper notification was issued and the then Hon'ble MLA released Rs.4.00 Lakh CDP funds for the road formation. The Panchayat Raj Department carried out the formation of Road from Pebbair PWD Road to Jammula Thanda and this formation work was recorded in official records. Further it is informed that the said road was illegally obstructed by the local landowners Shri Sayilu and his brothers. They forcibly destroyed the newly formed road and removed a previously constructed water check dam, causing severe damage to public property and depriving our community of crucial infrastructure. Despite clear evidence of unlawful acts and material damage to Government property, no effective action has been taken against these persons by local administration and police though criminal complaints were lodged by the petitioners.

6. The authority has stated that the District Panchayat Raj Engineer, PIU Division, Wanaparthy District has submitted his report stating that the Jammula Thanda is Habitation of Savaigudem Gram panchayat and covered by 195 population as per 2011 census and it is already connected with earthen road to savaigudem GP. Now the Government has sanctioned a BT Road of this habitation vide G.O.Rt No.71 of PR&RD (Roads) Dept. The work providing BT on R/f Savaigudem to Jammula Thanda in Wanaparthy Mandal and District has sanctioned under STSDF Grants and are in progress. Further it is mentioned that there is also a 1 Km earthen road located behind Jammula Thanda which connects to the Nachahalli-Pebbair Road. It is observed dthat if a small culvert is constructed at the required point, the route would become fully fuctional.

7. After hearing to the petitioner and authority the following observations/recommendations are made and the action taken report may be submitted in 30 days from the receipt of minutes.


a. The destruction of public property ie, Road and checkdam may be inquired into and necessary action may be taken on them besides restoring and repairing the same in a time bound manner in a month.

b. The entire documents as sought by the petitioner with respect to the sanction of the work, release of the funds etc for the said work may be provided to the petitioner.

c. The list of unconnected ST Habitations in the Wanaparthy District may be furnished to NCST along with the distances and population details of such habitations and the action plan to connect these with all weather road connectivity.




d. The rationale/justification in preferring to continue with 3 kilometre road rather than the 800 metre road that connects the ST habitation to the highway may be submitted to NCST.

e. The District Collector and District SP may submit a detailed report on the inaction of the Revenue and Police authorities over the grievance of the petitioner and attend to the next scheduled date of hearing of NCST in this matter.
