## NATIONAL COMMISSION FOR SCHEDULED TRIBES

Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Dilkusha Guest House, Hyderabad in the case of Shri Perumandla Venkanna, S/o Late Ramayya regarding non-issuance of pattas.

Date of the Sitting: 06/11/2025, 10:40 AM Participants in the Sitting: As per Annexure NCST/DEV-4956/TS/452/2025-RO-BHUV/RU-III

Shri Perumandla Venkanna, S/o Late Ramayya, along with 60 other farmers from Kesamudram Village and Mahmudpetnam Mandal in Mahabubabad District, vide rep dated 15.02.2025 have submitted a representation to the National Commission for Scheduled Tribes regarding government land under Survey No. 399/1 in Kesamudram Village. They stated that they have been cultivating approximately 75 acres of government land and 65 acres of fallow land for the past 15 years, without holding official pattas, while other farmers had already been granted pattas on similar land. They conducted a joint survey of the land and requested issuance of pattas to them as ST farmers without land, as they do not own any other cultivable land. A list of beneficiaries from the SC, ST, and BC categories cultivating land in Survey No. 399/1 was also provided, detailing their names, parentage, Aadhar numbers, and land holdings. They requested the Commission to intervene for issuance of pattas and resolution of their grievances.

- 2. NCST vide notice dated 16.05.2025 sought facts and comments from the Collector & District Magistrate, District- Mahabubabad and District Forest Officer District- Mahabubabad within 15 days.
- 3. Reply has not been received hence the Commission decided to discuss the issue with the authority and the petitioner on 06.11.2025. Accordingly, a Sitting Notice was sent on 28.10.2025.
- 4. The District Forest Officer, Mahabubabad and Additional Collector, Revenue, Mahabubabad have attended the eharing. The petitioner has also attended the hearing.
- 5. The petitioner submitted that during the change of the Government at the time of issuance of podu pattas some of the eligible farmers were left out and Hosuing pattas were also not issued as assured by the Government.
- 6. The authority has informed that a Joint survey was conducted on 22.8.25 by the Mandal surveyor, Mandal Girdhawar-I, Forest officials, along with the petitioners, farmers and villagers and during the joint inspection the locationw as identified in Sy.No.399/1 to an extent of Ac.242.24 Gts is Government land, ot of which to an extent of Ac.163.27 Gts as fallen in Ameenput block and Notified as Forest land vide Gazette No.1 Dated 3.1.1952. Out of notified forest area an extentof Ac.88.27 Gts is under cultivation by the Tribals for which ROFR Pattas were issued to the eligible 51 farmers. The petitioners are claiming the land in deep forest in Ameenpur Reserve Forest compartment No.115/7 and at no point of time it is under cultivation before 2005. It is further informed that all the eligible claimants were already given the FRA pattas.
- 7. After hearing to both the petitioner and authority the following recommendations were made and the Action taken report may be submitted in 30 days time.
  - a. The Gram sabha resolution of acceptance of eligible claimants list and ineligible claimants list at the time of FRC examination during the issuance of title deeds to the eligible cliamants may be submitted to NCST.

b. The eligible petitioners of BPL category may be provided with the Housing pattas in Kesamudram.
