NATIONAL COMMISSION FOR SCHEDULED TRIBES

Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Shri Tikan Soren regarding his dealership allotted under the Scheduled Tribe quota.

Shri Tikan Soren, Proprietor of Jharkhand Indane, Giridih, has stated vide petition dated 22.02.2022 that he was allotted an LPG distributorship under the ST quota in 2014 by Indian Oil Corporation Limited (IOCL) and has been operating it as per company norms. He had made his wife Smt. Yashoda Devi @ NuniMurmu a 50% partner through a registered partnership deed dated 18.09.2014. He alleged that one Shri Sudhir Kumar, who initially offered assistance in running the agency, later fraudulently replaced his wife's photograph and fingerprints in the partnership deed with those of his own wife, Smt. Kanchan Devi, with the intention of usurping the distributorship. On discovering this fraud, Shri Soren lodged an FIR at the SC/ST Police Station, Giridih, resulting in registration of Case No. 03/20 under multiple IPC sections and the SC/ST (Prevention of Atrocities) Act, 1989, and stated that Sudhir Kumar is presently in jail. He further mentioned that despite this, Sudhir Kumar and Kanchan Devi continue to submit false complaints to IOCL, alleging partnership and financial involvement, leading to repeated show-cause notices from the company. He denied receiving any financial help from them and clarified that the distributorship was allotted solely under his name as per the ST quota.

- In this matter, sitting were held on 14.10.2022 and 8.7.2024. In the last sitting held on 8.7.2024, the following recommendations were made and the minutes were circulated to all concerned on 12.8.2024 & 4.12.2024 respectively.
 - मामले में इंडियन ऑइल कारपोरेशन लिमिटेड द्वारा इस मामले को अग्रिम कार्रवाई हेत् प्राकृतिक गैस और पेट्रोलियम मंत्रालय, भारत सरकार को भेजा जाए।
 - इसमें इस बात का ध्यान रखा जाए कि शिकायतकर्ता अशिक्षित और अनुसूचित जनजाति के सदस्य हैं, इसलिए न्यायसंगत और सकारात्मक सिफारिश की जाए।
 - मामले में सकारात्मक कार्रवाई हेतु आयोग की ओर से प्राकृतिक गैस और पेट्रोलियम मंत्रालय , भारत सरकार को लिखा जाना है।
- The Ministry of Petroleum & Natural Gas vide letter no. M-13026(16)/5/2024-LPG-PNG has informed that the matter is complex in nature and needs further examination in the Ministry. There was no response received from authorities, hence, Commission has decided to discuss the issue with the authority and the petitioner on 10.11.2025. Accordingly, a Sitting Notice was sent on 04.11.2025. The Chairman, IOCL vide letter no. CH/01 dated 6.11.2025 has sought exemption and deputed ED (LPG) Head Office to attend the same.
- In the sitting, the ED(LPG), alongwith other officers of IOCL and petitioner were present. The petitioner has reiterated his earlier submissions and requested for justice. The officers from IOCL has provided the letter no एसएल /एनसीएसटी /1803 dated 6.11.2025 which contains the Action taken report. It was informed that the petitioner is Graduate. Further, it was informed that the distributorship shall remain operational until the Commission reaches a logical conclusion vide NCST letter dated 28.10.2022. The officers also informed that the petitioner has committed the fraud while getting the distributorship.
- During discussion, it was observed that the IOCL can take decision in the case in consultation with the Ministry of Petroleum and Natural Gas, as the comments/ views of Ministry has not been received.
- After discussion with the officers of IOCL and petitioner, it was observed that at present there is no action warranted on part of NCST because it is a policy issue. IOCL is advised to take decision in the case in consultation with the Ministry of Petroleum and Natural Gas.
