NATIONAL COMMISSION FOR SCHEDULED TRIBES

Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at LokNayak Bhawan, New Delhi in the case of Shri David Touthang, Manager (dismissed), Indian Oil Corporation Limited regarding dismissal from service.

Date of the Sitting: 10/11/2025, 05:30 PM Participants in the Sitting: As per Annexure NCST/SER-2276/MPNG/2/2025-RU-III

Shri David Touthang, Manager(dismissed), Indian Oil Corporation Limited, vide his representation dated 11th April 2025, has stated that he had joined Indian Oil Corporation Ltd. on 3rd June 2013 as a Marketing Officer and had been serving in various locations in the North Eastern states. He was transferred from Sekmai Bottling Plant, Manipur to Silchar Bottling Plant, Assam, and was to report by 9th June 2023; however, due to the crisis in Manipur from 3rd May 2023, he could not join his new posting as he had to take care of his ailing parents and displaced relatives. Despite regularly informing the office about his situation and later expressing readiness to resume duty with a request for a safer posting, he was informed via email dated 29th October 2024 (Ref. No. IR/1461/B/504107 dated 25.10.2024) that he had been dismissed from service. He claims to have appealed within the stipulated time but has received no response. He has requested the Commission's intervention to ensure a fair and just resolution, terming his dismissal unfair and discriminatory considering the exceptional circumstances.

- 2. NCST vide notice dated 21.5.2025 sought facts and comments from the Chairman, Indian Oil Corporation Limited within 30 days.
- 3. Indian Oil Corporation Ltd. (Marketing Division), vide letter no. Nil dated 18.06.2025 has informed that the petitioner was promoted and transferred from Sekmai Bottling Plant, Manipur to Silchar Bottling Plant, Assam vide order dated 12.04.2023 with a joining due date of 09.06.2023. Owing to the crisis in Manipur, Shri Touthang requested permission to continue at his current location and extension for joining was granted till 30.06.2023. Despite repeated advice, he failed to report for duty and remained unauthorizedly absent from 26.07.2023. A recordable warning was issued on 09.10.2023 followed by a charge-sheet dated 08.04.2024 after prolonged absence. Disciplinary proceedings were held at Guwahati on 13.06.2024 and 18.06.2024, where he admitted the charges. The Inquiry Officer, vide report dated 16.08.2024 found the charges proved and after due process, the competent authority imposed the penalty of removal from service on 25.10.2024. IOCL stated that Shri Touthang's later claim of travelling to join duty on 28.10.2024 was irrelevant as he had not joined till the final order date. It was further informed that his appeal dated 22.12.2024 is under consideration. This was sent to the petitioner vide NCST letter dated 06.08.2025.
- 4. The Commission has decided to discuss the issue with the authority and the petitioner on 10.11.2025. Accordingly, a Sitting Notice was sent on 04.11.2025. The Chairman, IOCL vide letter no. CH/01 dated 6.11.2025 has sought exemption and deputed ED(HR) to attend the sitting.
- 5. In the sitting, ED(HR) alongwith other Sr. officers of IOCL were present. The petitioner joined via phone. The petitioner reiterated his earlier submissions and stated that he did not join at Silchar strictly due to safety concern and he had repeatedly requested posting at any other place in India but that was denied. The officials of IOCL informed that they had given the petitioner Eight months and only then they had started proceedings while the rule allowed them to start the same after 21 days only. They further stated that even during the proceedings and appeal, the petitioner had not shown willingness to join any other place in India. Hence IOCL had proceeded as per rules and his appeal was also dismissed in August 2025. The petitioner again informed stated that he is ready to join any other place in India instead of Silchar owning to its proximity to the areas of voilence againist kukis.
- 6. During discussion, it was observed that the petitioner belongs to the Kuki ST community of Manipur and there was a genuine safety concern in his joining at Silchar at that time. Further his willingness to join at any other place in India shows that the reason for not joining at Silchar was genuine. The order of dismissal appears to be disproportionate and needs reconsideration. This was shared with the concerned officers of IOCL and advised that an opportunity for joining in service to the petitioner may be given. The official of IOCL has assured that the petitioner may be advised to meet at Mumbai on 18th Nov, 2025 with documentary evidences of his communication with IOCL.

IOCL to re-examine the issue on humanitarian grounds for reinstatement of the petitioner into service.
